BECAUSE THERE ARE LEGAL PREREQUISITS FOR CREMATION ABC CANNOT GUARANTEE CREMATION WILL OCCUR IN A PARTICULAR TIMEFRAME. AS A STANDARD PLEASE ALLOW UP TO FIVE WORKING DAYS FOR A DIRECT CREMATION TO BE COMPLETED FROM TIME OF DEATH.

STATE AND LOCAL LAWS DO NOT REQUIRE A CASKET FOR DIRECT CREMATION. If you want to arrange a direct cremation, you can use an alternative container.

Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are alternative containers (Wood Reinforced Cardboard)

PROFESSIONAL SERVICES

- **Basic Services Of A Better Cremation & Staff**.....\$ 1350.00
This fee includes, but is not limited to; arrangement conference; coordination with crematory and/or cemetery for final disposition of the cremated remains; procurement, preparation and filing of necessary notices; general administration expenses; general overhead expenses and governmental compliance. The fee for our basic services and overhead will be added to the total cost of the arrangement you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.) We also include a Virginia Medical Examiners Fee in this charge.
- **Cremation Fee**.....\$ 500.00
- **Direct Cremation**.....\$2325.00 to \$2475.00

Our charges (without ceremony) include: removal from place of death (within 25 miles), administrative and staff services, preparation of remains for cremation, refrigeration (up to 48 hours), transportation to our crematory, cremation, temporary receptacle for cremated remains and filing of death certificate.

CREMATIONS AND BURIALS AT SEA: "No dead human body whose death occurred in Virginia shall be cremated or buried at sea, **IRRESPECTIVE OF THE CAUSE AND MANNER OF DEATH**, unless a medical examiner shall determine that there is no further need for medicolegal inquiry into the death and shall so certify upon a form supplied by the chief medical examiner. For this service the medical examiner shall be entitled to a fee established by the Board, not to exceed the fee provided for in subsection D of Section 32.1-283, to be paid by the applicant for the certificate."

This package includes a local removal, temporary custody of the decedent's remains and refrigeration for up to 48 hours, an alternative container for safe handling, and filing of the death certificate (Does not include Death Certificate copies or other cash advances).
- **Scattering at Sea of Cremated Remains**.....\$200.00
Scattering of cremated remains at sea is irreversible, once completed it cannot be undone. Scattering will be completed at sea off the eastern seaboard at least 3 miles from shore. Exact location and time of scattering will be at Hill & Wood's/ABC's sole discretion. Due to limited space on the vessel, scattering will be carried out by staff of Hill & Wood or ABC. No Family May Be Present unless otherwise specifically agreed in writing.
