### INDEPENDENTLY OWNED

If legal or other requirements mean you must buy any items you did not ask for, we will explain the reason in writing on the statement we provide describing the funeral goods you select.

This list does not include prices for certain items that you may ask us to buy for you, such as flowers and newspaper notices. The prices for those items will be shown on your bill or the statement describing the funeral goods and services you selected.

## SERVICES OF FUNERAL HOME AND STAFF

---

### **Minimum Service of The Funeral Director and Staff** **\$2,842.00**

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

- A. Staff and facilities to respond to initial requests for services, and arrangements conference with responsible party to determine services desired.
- B. Coordinating service plans with cemetery, crematory, and/or other parties involved in the final disposition of the deceased.
- C. Securing official documents and necessary registration.

### **Embalming** **\$675.00**

Except in certain cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you have the right to choose an arrangement which does not require you to pay for it, such as direct cremation, green burial, or immediate burial.

## **What Types Of Payment Are Accepted?**

We accept payment by cash, check, VISA, MasterCard, Discover and Amex. We welcome assignments of life insurance policies or prepaid burial policies. We also accept payment from Municipal Assistance Programs, and have credit financing and crowd-funding initiatives available through our Tribute Pay Center™ at [www.brackettfh.com](http://www.brackettfh.com).

## **Is a Deposit Required?**

Yes, and it will vary depending on the method of payment and the services you choose. Except in the case of public assistance or use of most policy assignments, the anticipated costs of selected services and merchandise is requested at the time of arrangements. (A sum equal to Section A and B of your executed SFG). With the selection of Direct Burial, Direct Cremation, a Cremation or Green Burial service package, full payment is due at the time of contract signing.

*\*\*Brackett Funeral Home reserves the right to delay the order of merchandise and/or scheduling of services until deposit is received.*

## **When Is Settlement Payment Due?**

Unless unique circumstances exist, your director will have a finalized bill including all cash advance items (that were paid forward on your behalf) available once all services are completed and rendered. You should expect the finalized bill to be mailed, with a notice of any remaining balance due, to the address you provided as purchaser.

As our Statement of Goods and Services states, "...the total balance (is) due and payable within 30 days...if full cash settlement is not made within 60 days, a late charge of 1.5% per month may be added to the unpaid balance."
