## GENERAL PRICE LIST

These prices are effective January 1, 2024, but are subject to change without notice.

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

BASIC SERVICE FEE \$795

This fee for our basic services and overhead will be added to the total cost of the arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

This fee includes the following:

Personnel available 24 hours a day, 365 days a year to respond to initial call

Arrangement conference with licensed director

- Coordinating service plans with cemetery, crematory, and/or other parties involved in the final disposition of the deceased
- Clerical assistance in the completion of various forms associated with disposition
- Overhead expenses, including facility maintenance, equipment, and inventory costs

Insurance and administrative expenses

Permanent record retention as required by state regulations

#### **PREPARATION**

Embalming

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

## **DIRECT CREMATION (AQUAMATION)**

\$1275 to \$7875

Our charge for direct cremation (without ceremony) includes transfer of remains to funeral home, refrigeration, basic services of funeral director and staff and aquamation fee at Tranquility Aquamation (on-site).

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). We do not use containers in the aquamation process. If desired, an alternative container made of cardboard and the use of a 3<sup>rd</sup> party, off-site flame crematory is available.
