## WHERE TO BEGIN

Planning a funeral can be overwhelming, but you are not alone in this. We're here to support you throughout this journey and make this process one of love, healing, and life celebration. Below is some information to help you get started, but you can contact us at any time if you need help.

#### Within Hours

When a loved one dies at home or in a place that isn't a healthcare facility, you'll need to contact emergency personnel before they can be taken into our care. If your loved one was under medical care, it's a good idea to call their physician as well.

If your loved one dies in a healthcare facility, they will notify the proper authorities, including the funeral home you have chosen to care for your loved one if they know that information.

Emergency and medical personnel involved in this part of the process will help you with obtaining a medical certificate and any other necessary paperwork.

This part of the process is often the most emotional, and we are here to help and support you. If you're not sure what to do, call us any time.

### Within the First Few Days

You'll want to notify close friends and relatives, both through personal phone calls as well as your loved one's death notice. If this process is too painful for you, it's absolutely okay to ask a trusted family member or friend to help you.

This also is the time to review any of your loved one's preplanned funeral wishes and meet with a funeral director to begin planning their service. If your loved one did not preplan their funeral, you might want to start thinking about a few of the big choices you will need to make, such as:

Burial or cremation

- If burial, the type of casket
- If burial, the location of their final resting place in a grave or mausoleum
- If cremation, the type of urn
- If cremation, the location of their final resting place through burial or scattering
- Any religious services you will need, such as clergy or spiritual leaders
- The types of services you want, such as a viewing, service, graveside memorial, etc.

These questions are just a starting point, and you don't need to know the answers right away. Don't hesitate to contact us to gain a better understanding of your options. We're here to make this process easier for you.

### What to Expect When We Meet

When you meet with a member of our staff to discuss your arrangements, we'll first provide you with a general price list to give you a basic idea of what our services cost.

We'll then ask you about your loved one to gain an understanding of the person the services will honor. Use this time to communicate your ideas and preferences, share your loved one's life story, revisit memories, and highlight their accomplishments. Our professionals will use this information to guide you in the creation of a personalized, meaningful celebration of your loved one's life.

This process may include:

- Preparing and filing the official death certificate
- Scheduling the services and events (including the location, date, and time)
- Selecting a casket, urn, or other products you may need
- Drafting an obituary
- Arranging necessary transportation
- Selecting pallbearers

We'd like to make this process as smooth and stress-free for you as we can, so remember to bring the following information about your loved one with you as well:

- Full legal name and home address
- Social security number
- Date of birth
- Place of birth
- Father's name
- Mother's maiden name
- Veteran's discharge papers (DD-214), if applicable
- Highest education
- Occupation
- Information about the burial location if applicable
- Clergy name and phone number if applicable
- Names and relationships of survivors
- Insurance policy information if using to pay for funeral expenses

Please also bring a recent photograph and any clothing you'd like us to use when dressing them for the service.

### GENERAL PRICE LIST

These prices effective January 1, 2024 – Prices are subject to change without notice.

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Our charges for the service of funeral director and staff include, but are not limited to: staff to respond to the initial requests for service, arrangement conference with family or responsible party, coordination with cemetery, crematory or other parties involved with the final disposition of the deceased, preparation and filing of necessary notices, authorization and permits. Also included in this charge are overhead expenses such as professional licensing and accounting fees, insurance, building and utility expenses, parking lot and grounds, maintenance, furnishings, record keeping, secretarial and administrative expenses. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

Embalming......\$1,150.00\*

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

### Cremation (with visitation only)......\$4,405.00

This charge for cremation with visitation includes professional services of funeral director and staff; transfer of remains to funeral home, embalming, dressing and cosmetics, use of facilities, equipment and staff for viewing, cremation, cremation permit with temporary cremation container. This charge does not include casket, airline shipping charges or death certificates.

### Cremation (with traditional funeral service)......\$4,905.00

This charge for cremation and traditional funeral service includes professional services of funeral director and staff, transfer of remains to funeral home, embalming dressing and cosmetics, use of staff and equipment facilities for viewing and funeral ceremony, use of hearse, use of (1) Limousine within 50 mile radius, cremation, cremation permit and temporary container.

### Forwarding of Remains to Another Funeral Home.....\$2,200.00

Our charges for this service includes transfer of remains to funeral home, embalming, hearse transportation, necessary services of staff, coordination with receiving funeral home, necessary authorizations and shipping container required by airline. This charge does not include casket, viewing, and airline shipping charges or death certificates.

### Receiving of Remains from Another Funeral Home (Casketed)......\$2,400.00

This charge includes transfer of remains to funeral home, temporary shelter of the remains, transportation of remains to cemetery or crematory and professional services of funeral director and staff. It does not include the use of facilities for viewing or for the funeral rites/ceremonies.



## SOCIAL SECURITY BENEFITS

The following checklist is designed to help you file for your Social Security benefits correctly so that prompt payments may be made.

### Eligibility

To receive monthly benefits, the deceased worker must have credit for work covered by Social Security ranging from 1 1/2 to 10 years depending on his or her age at death. Those eligible for monthly benefits include:

- A widow or widower age 60 or older (50 if disabled) or at any age if caring for an entitled child who is under 16 or disabled
- A divorced widow or widower age 60 or older (50 if disabled) if the marriage lasted 10 years or if caring for an entitled child who is under 16 or disabled
- Unmarried children up to 18 (19 if they are attending a primary or secondary school full-time)
- Children who were disabled before reaching 22 as long as they remained disabled
- Dependent parent or parents 62 or older

### **Lump-Sum Death Payment**

A one-time payment of \$255 is paid in addition to the monthly cash benefits described above. The lump-sum death payment (LSDP) is paid in the following priority order:

- A surviving spouse who lived in the same household as the deceased person at the time of death
- A surviving spouse eligible for or entitled to benefits for the month of death
- A child or children eligible for or entitled to benefits for the month of death

### **Applying for Benefits**

You must apply in order to receive benefits. You may apply at any Social Security office, by telephone at 1-800-772-1213, or online at www.ssa.gov.



### HONORING VETERANS

We're proud to do our part in honoring our country's veterans. Our duty is to provide you and your family with professional and dignified assistance during your time of need, and we promise to support you in honoring your loved one for their dedication and selfless service.

### **Eligibility**

- Military funeral honors are free of charge and mandated by law for eligible veterans. Eligibility will be veri fied by the veteran's DD-214, or discharge papers. Eligible members include:
- Military members on active duty or in the Selected Reserve.
- Former military members who served on active duty and departed under honorable conditions.
- Former military members who completed at least one term of enlistment or period of initial obligated service in the Selected Reserve and departed under honorable conditions.
- Former military members discharged from the Selected Reserve due to a disability incurred or aggravated in the line of duty.

### **Traditional Honors**

At minimum, eligible veterans are entitled to the folding and presenting of the American flag to the next of kin and the playing of Taps by a bugler or recording. These honors are performed by an honor guard detail that consists of at least two members of the Armed Forces. One member must be a representative from the branch in which the veteran served, and this member will be the individual who presents the flag.

#### Honors also can include:

A three-volley rifle salute to represent duty, honor, and country The U.S. flag draped over the casket A final salute at the gravesite

#### **Veteran Benefits**

In addition to coordinating honors related to the service itself, we can help you communicate with the U.S. Department of Veterans Affairs (VA) to arrange for:

A Presidential Memorial Certificate: This is a certificate expressing the nation's recognition of the veteran's service. The veteran's name is inscribed, and the certificate bears the signature of the President.

Headstones or markers: The VA provides headstones and markers for the graves of veterans anywhere in the world and for eligible dependents of veterans buried in national, state, or military cemeteries.

Memorial plots: If an eligible veteran's remains are not available for burial, the VA will provide a plot and headstone or marker in a national cemetery for memorialization. If you wish to place the memorial in a cemetery other than a national cemetery, the VA will provide the headstone or marker but not the plot itself.

Burial in a VA national cemetery: This includes the gravesite, opening and closing of the grave, a grave box, and perpetual care.
