#### **GENERAL INFORMATION: DISCLOSURES**

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. **However, any funeral arrangements you select will include a charge for our basic services and overhead.** If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

This list does not include items that you ask us to buy for you, such as honoraria, death certificates or crematory services. The prices for those items will be shown on your bill or the statement describing the funeral goods and services you selected.

#### BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF: \$3,100.00

Our fee for the services of the funeral director and staff includes, but is not limited to, staff to respond to initial request for services; arrangement conference with family or responsible party; preparation and filing of necessary certificates and permits. Recording vital statistics; preparation and placement of obituary notices; preparation of services; and coordination with those providing other services, such as clergy, cemetery, crematory and others. Also included in these charges are overhead expenses relative to our facility such as insurance, maintenance and utility expenses, secretarial and administrative costs and equipment and inventory expenses.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burial and forwarding or receiving of remains.)

EMBALMING: \$900.00

Embalming is not required by law. Embalming may be necessary, however if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

- Payment from Estate
  - \*Estates Since it normally takes three months to one year to probate and settle an estate, we ask that those responsible for making funeral arrangements find a more timely method of payment. If we find it necessary to file a claim against the estate the following will apply.
    - We will charge an Estate Filing Fee of \$250.00 and will also apply the late fee until the payment in full from the estate is made.
    - The person authorizing our services will be responsible in the event that all or part of the payments due on the account are not received from the estate.
