If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statements we provide describing the funeral goods and services you selected.

SERVICES OF FUNERAL DIRECTOR AND STAFF

Our professional service charge includes but is not limited to counseling, availability on a 24-hour basis, consultation with family and clergy, assistance of staff in all necessary phases of arrangements, obtaining, preparation and filing of necessary notices, authorization and consents, certificates and permits, coordination with those providing other portions of the funeral, e.g., cemetery, crematory, and others, and assistance to the family following funeral and final disposition. Included in this charge are overhead expenses relative to our facility such as insurance, maintenance and utility expenses, secretarial and administrative costs, and equipment and inventory expenses.

EMBALMING

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangement, such as a funeral with viewing.
