Please Be Advised:

- All concrete foundations will be installed by the Cemetery at the prevailing price and will be constructed, weather permitting, up to October 1.
- Flush granite marker, restricted to 2 ft x 1 ft by 4 in thick and 1/4 in tolerance. Rock or sawed sides, incised inscription only (sand/stone foundation).
- Baby section — same requirements apply except size is restricted to 18 in x 10 in.
- All bronze memorialization must have a granite base 28 in x 16 in by 4 in thick, to be purchased from the Cemetery.
- Only Granite Stone Monuments Permitted.
- Complete and detailed drawing showing exact length, width and height of base and die stone, inscription(s), and/or permanent parts of material other than stone, must be

PROPOSED MARKER DESIGN

Please submit order to cemetery for approval before manufacturing.

- All monumentation entering all Mount Calvary properties must be identified, inspected and passed at the service center before erection on lot. Hours available for inspection are Mon—Fri 9 a.m.—noon and 1:00 p.m.—3:00 p.m.; Saturday 9 a.m.—11:00 a.m.
- No adornments, embellishments or changes of any kind can be made to a monument, once erected. Requests for such must be made through the office in the same manner in which original documentation was filed.
- By signing below, the Monument Dealer guarantees all charges, and shall be liable for any damage caused during the erection of the memorial.
