These prices are effective as of July 1, 2023 and are subject to change without notice.

## 

Transportation of the body within 30 miles of our facility, preparation of the required documents and authorizations, "Worry Free" Cremation in our Crematory, Alternative cremation and temporary containers, Final Goodbye at our facility during normal weekday business hours for up to 15 immediate family members.

With this option there is no embalming and only a very limited time that the deceased may be transferred out of refrigeration and identified. So that the deceased remains in an essentially refrigerated state, we respectfully request that the identification be for no more that 30 minutes from the time we agree to begin. In the case of autopsied remains, embalming is necessary (additional fees).

# "Just a Simple Cremation".....

Transportation of the body within 30 miles of our facility, preparation of the required documents and authorizations, "Worry Free" Cremation in our Crematory, Alternative cremation and temporary containers.

## Cremation with Memorial Service.....

Transportation of the body within 30 miles of our facility, preparation of the required documents and authorizations, "Worry Free" Cremation in our Crematory, Alternative cremation and temporary containers, Visitation to be held one hour immediately prior to funeral service at your church or our facility during normal weekday hours, Coordination and supervision of memorial service at your church or our facility, Basic guest register book, 100 memorial folders and 25 thank you notes.

This service includes: the services of the funeral director, transportation of the body within 30 miles of our facility, embalming, preparation of the required documents and authorizations, visitation to be held one hour immediately prior to funeral service at your church or our chapel during normal weekday business hours, coordination and supervision of funeral service at your church or our facility, use of standard wood rental casket, "Worry Free" Cremation in our Crematory, Alternative cremation and temporary containers, Basic guest register book, 100 memorial folders and 25 thank you notes.

These services do not include: merchandise such as cremation urn, services such as graveside committal service; clothing, hair dresser, sundries or any cash advance items. If decedent weighs over 300 pounds, there will be an additional charge for the cremation.

# ITEMIZED SELECTIONS

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for we will explain the reason in writing on the statement we provide describing the funeral goods and services you select.

This is the basic charge to each family which we serve, for our professional expertise in assisting them. It includes, but is not limited to, a proportionate share of the taxes, licenses, utilities and business expenses necessary to serve the public in a professional manner. Also included in this charge is the consultation with the family, clerical and administrative services, preparation and filing of necessary permits, consultation with the clergy, cemetery, crematory, common carrier, assistance with insurance papers, planning the funeral or memorial service and placement of obituary notices. There will be an additional charge for the direction and supervision of each service requested or required.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included with our charges for our cremation service packages, immediate burials, and forwarding or receiving remains)

# Embalming and Professional Care.....

Embalming is a chemical process which provides temporary preservation of the body and eliminates certain health hazards. A person licensed by this state must complete this procedure.

Except in certain special cases, the law does not require embalming. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with public viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

# ADDITIONAL PERSONALIZED SERVICE PROGRAM PACKAGES

(Complete Traditional Service, Graveside Service with Prior Day Visitation, and Immediate Burial reflect a \$500.00 discount for combination with a casket from our selection.)

### Complete Traditional Service .....

This service includes: the services of the funeral director and staff, administrative staff and professional staff for coordinating and directing the service; obtaining legal documents and other paperwork necessary to complete the arrangements; removal of the deceased from the place of death to our facility within a 30 mile radius; embalming and/or sanitary care of the remains; other preparation of the remains, dressing, casketing, cosmetizing; use of the facilities and staff for prior day visitation (3 hours max, between 11:00 am - 5:00 pm, weekdays); use of the facilities for the service or set up at church or other facility during regular weekday business hours; mini hearse.

This service does not include: merchandise selected such as casket, memorial register book; memorial service folders & acknowledgment cards, cemetery receptacle, police escort to cemetery, clothing, hairdressing, transportation beyond 30 miles, family car, sundries or any cash advance items i.e. obituaries, flowers, death certificates.

# Graveside Service with Prior Day Visitation ......

This service includes: the services of the funeral director and staff, administrative staff and professional staff for coordinating and directing the graveside service; obtaining legal documents and other paperwork necessary to complete the arrangements; removal of the deceased from the place of death to our facility, within a 30 mile radius; embalming and sanitary care of the remains; other preparation of the remains, dressing, casketing, cosmetizing and the use of the facilities for viewing (up to 2 hours between noon and 5 PM weekdays on the day prior to the graveside service); transportation of deceased to cemetery (family gathers at graveside no procession).

> This service does not include: merchandise selected such as casket, memorial register book, memorial service folders and acknowledgment cards, cemetery receptacle, clothing, hairdressing, transportation beyond 30 miles of our facility, family car, sundries or any cash advance items.

### Immediate Burial ..

S2.100

This service includes: the services of the funeral director and staff, administrative staff and professional staff for obtaining legal documents and other paperwork necessary to complete the arrangements; removal of the deceased from the place of death to our facility, within a 30 mile radius; sanitary care of the remains; transportation to cemetery during weekday for burial.

This service does not include: embalming, other preparation of the remains, refrigeration, viewing or use of facilities for viewing and merchandise such as casket, clothing, memorial package, cemetery receptacle, cemetery charges and equipment rental or any cash advance items. Casket can be selected with costs begin at \$895.

(This service is a basic cremation without service or ceremony.)

This service includes: a proportional charge of the Basic Services of Funeral Director and Staff, administrative staff and professional staff for obtaining legal documents and other paperwork necessary to complete the arrangements; removal of the deceased from the place of death to the Memorial Center, within a 30 mile radius; care and custody of the remains; positive identification by authorization agent or authorized representative, OSHA approved cremation container as required by crematory; transportation to crematory and crematory fee.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers contain the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are: cardboard.

This service includes professional services of funeral director and staff, removal from place of death within 30 miles from our facility, care and custody of body up to 300 pounds, embalming and preparation of the body for viewing, securing all permits and documents, funeral service conducted at your church or other appropriate facility during normal weekday business hours (3 hours max), all transportation within 30 miles of our facility, basic guest register book, 100 memorial folders, standard 20 gauge steel

## Green Burial.....

(This service is a basic burial without service or ceremony.)

This service includes: the services of the funeral director and staff, administrative staff and professional staff for obtaining legal documents and other paperwork necessary to complete the arrangements; removal of the deceased from the place of death to our facility, within a 30 mile radius; sanitary care of the remains; local transportation to cemetery during weekday for burial.

This service does not include: embalming, other preparation of the remains, refrigeration, viewing or use of facilities for viewing and merchandise such as casket, clothing, memorial package, cemetery receptacle, cemetery charges and equipment rental or any cash advance items. Casket can be selected with costs begin at \$1,095.

# Forwarding Remains to another Funeral Home.....

\$1,675

This service includes: basic services of the funeral director and staff, administrative staff and professional staff for obtaining legal documents and other paperwork necessary to complete the transfer; removal of the deceased from the place of death to our facility, within a 30 mile radius; embalming or other sanitary care of the remains; basic use of the facilities.

This service does not include: dressing, casketing, cosmetizing and hair care, refrigeration, viewing or use of facilities for viewing and merchandise such as memorial package, casket or alternative container; transportation to common carrier, use of automotive equipment, other funeral director charges, taxes or any additional services.

# Receiving Remains from another Funeral Home......

\$1.350

This service includes: the basic services of the funeral director and staff, administrative staff, transportation to local cemetery within 30 mile radius during weekday.

This service does not include: embalming or other preparation of the remains, dressing, casketing, cosmetizing and hair care; casket or alternative container; visitation or viewing services; service merchandise; automotive equipment except as specifically set forth above; cash advances; other funeral director charges; taxes or other additional services.

# Anatomical Body Donation.....

\$895

When an individual chooses to donate their body to science. This service includes: the services of the funeral director and staff, administrative staff and professional staff for obtaining legal documents and other paperwork necessary to complete the arrangements; removal of the deceased from the place of death to the donation site, within a 30 mile radius; care and custody of the remains; vehicle for transportation of body.

This service does not include: additional mileage to donation site, embalming, other preparation of the remains, refrigeration beyond 24 hours, viewing or use of facilities for viewing or service, and merchandise such as memorial package or any cash advance items.

Additional charges shall apply for individual cases over 300 pounds.

### MERCHANDISE

We offer many different styles and prices of caskets and a alternative container from which to select. Since many caskets that appear similar in appearance may differ greatly in quality or construction, we offer the following in order to assist you in making an informed decision.

**Gasket:** these caskets are designed by the manufacturer to resist the entrance of air, water and other outside elements. They may be constructed of varying gauges of steel, copper or bronze.

**Non-Gasketed:** these caskets are not designed by the manufacturer to resist the entrance of air, water and other outside elements. They may be constructed of metal, hardwood or wood products with fabric.

# PAYMENT POLICY

To lose someone you love is a devastating experience. It is frequently traumatic and can seriously impact judgment. We believe in the importance of the recognition and meaningful celebration of a life that has been lived and will assist in arranging an appropriate service to meet your individual needs.

It is also important to be realistic in respect to funeral expenditures. We do not want a family to spend more than they should nor less than they would like. What is important is that arrangements be in keeping with a family's wishes and budget.

<u>Provisions for payment are due at time of arrangements.</u> To avoid any possibility of misunderstanding or embarrassment and for your convenience, we accept the following methods of payment:

Cash - Check - Debit Card - ACH (e-check)

Credit Cards (2% fee will apply): Visa - MasterCard - Discover - AmEx

Insurance Assignment of a verifiable policy (\$150 processing fee)

Prepaid Arrangements

It is NOT the policy of Ohio Cremation & Memorial Society to bill an estate. In cases where the deceased's estate must stand the burden of paying the funeral expenses, we ask that a family representative pay the funeral expenses and file claim for reimbursement with the deceased's estate.

### Cash Advance Items as Selected.

Third Party Cash Advance Items – Payment for cemetery, crematory, flowers, obituaries, death certificates, state sales tax, and honorariums of any type are required in the form of a check or cash before funeral services because each of these requires payment when their service is provided.

Unfortunately, since these are not our charges, we do not accept credit cards for these items.

### Ohio Sales Tax applies to all merchandise and some services.

**Obituaries:** Prepared obituaries will be faxed or emailed by Ohio Cremation & Memorial Society to all newspapers requested by the authorizing agent. Any charges by the newspaper must be covered by a credit card at the time the obit is sent to the newspaper. Ohio Cremation & Memorial Society does not author obituaries and is not responsible for content or editing by newspaper.

**Certified Copies of DEATH CERTIFICATES:** Ohio Cremation & Memorial Society is responsible for filing a completed Death Certificate with the Health Department in the county where the death occurred. We depend upon the United States Postal Service to deliver the death certificate to the doctor, back to us, and then to the Health Department. The family may order certified copies from the Health Department directly via fax, internet, phone or mail. This process takes a minimum of 2 weeks. If you wish for us to attempt to expedite the process there will be an additional charge with no guarantee of time savings.

Personal Effects on the deceased at the time of death, or personal effects placed on the deceased for viewing purposes will be buried or cremated with the deceased unless specifically requested to be returned. If you would like the personal effects of the deceased from the time of death (such as the clothing, bedding, or jewelry) please ask for them, if not, we reserve the right to dispose of them after a 30-day period.

Ohio Cremation & Memorial Society reserves the right to bury any unclaimed cremated remains (defined as: any cremated remains still in the custody of the funeral home 365 days following the cremation) in a common grave.
