## GENERAL PRICE LIST

Prior to drafting any contract for goods or services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any preneed agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent.

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

### BASIC SERVICES OF FUNERAL DIRECTOR & STAFF.....\$ 1100

Our fee includes funeral consultation, necessary arrangements, recording vital statistics, securing permits, filing and obtaining death certificates and other forms and claims, preparation of necessary notices, and coordination of service plans with parties involved in the final disposition of the deceased. **This fee is for our basic services and overhead which will be added to the total cost of the funeral arrangements you select. This fee is already included in a limited manner, in our charges for direct cremation, immediate burials, and forwarding or receiving remains.**

### EMBALMING.....\$ 700

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

### OTHER PREPARATION OF REMAINS

- Casketing remains. Non-applicable for a direct cremation if in a cardboard box .....\$ 200
- Dressing, Cosmetizing, Hairdressing .....\$ 200
- Special care for the repair of autopsied remains .....\$ 300
- Special care for the repair of remains which has had anatomical donations .....\$ 300
- Refrigeration / Shelter of remains .....\$ 500

### ADDITIONAL SERVICES AND FACILITY USE

- Funeral Ceremony conducted at funeral home .....\$ 500
- Funeral Ceremony conducted at church .....\$ 500
- Visitation at funeral home ( 2 pm – 5 pm ) .....\$ 500
- Visitation at funeral home ( 5 pm – 8 pm ) .....\$ 700
- Visitation 1 hour prior to service conducted at funeral home or church .....\$ 350
- Visitation conducted at church (delivery, setup, pick up) .....\$ 700
- Memorial Service conducted at funeral home or church .....\$ 500
- Graveside Service .....\$ 500
- Weekend, Holiday, after regular business hours (5 pm) fee .....\$ 800

### TRANSPORTATION

- Transfer of remains to funeral home. (Add \$ 200 if residential, \$ 100 after 5 pm) .....\$ 600
- Funeral Vehicle / Hearse .....\$ 400
- Utility Vehicle (to or from airport / cemetery / for long distance) .....\$ 200
- Delivery of cremated remains (within Monterey County / Shipping, Handling, Posting) .....\$ 200
- Transportation to California / Mexico border .....\$ 2000
- Transportation to Los Angeles County .....\$ 1500
- Transportation to Sacramento .....\$ 900
- Transportation to San Francisco .....\$ 800
- Transportation to San Jose .....\$ 600

### FORWARDING REMAINS TO ANOTHER FUNERAL HOME.....\$ 1700

This fee includes removal of remains, limited services of funeral director & staff, necessary authorizations, embalming & local transportation to air facility. Shipping charges and staff & facilities for visitation are not included.

### RECEIVING REMAINS FROM ANOTHER FUNERAL HOME.....\$ 1700

This fee includes local transportation to the funeral home, limited services of funeral director & staff to oversee interment and vehicle to local cemetery. Use of facilities, funeral director or staff for visitation or funeral services are not included.

### IMMEDIATE BURIAL.....\$ 1700

This fee includes local removal, care of remains, transportation to local cemetery, limited services of funeral director & staff to oversee interment and securing of necessary permits and authorizations.

### DIRECT CREMATION.....\$ 1500

This fee includes local removal, care of remains, transportation to local crematory, cremation fee, limited services of funeral director & staff, securing of necessary authorizations & permits, and minimum alternative (cardboard) container.

This fee does not include identification, witnessing a cremation, visitation, use of facilities for services, or certified death certificates.
