* We estimate that this \$8.7 million increase in net sales is comprised of: (i) approximately \$56.4 million of higher sales volume; (ii) approximately \$10.4 million from DECO operations, which we acquired in July 2017; partially offset by (iii) approximately \$54.8 million in sales attributable to an additional five days in fiscal 2016; (iv) approximately \$2.7 million in reductions from pricing, resulting from changes in customer and product mix, discounting and other items; and (v) approximately \$0.6 million from an unfavorable foreign exchange impact.

** We estimate that this \$24.2 million increase in net sales is comprised of: (i) approximately \$113.8 million of higher sales volume; (ii) approximately \$10.4 million from DECO operations, which we acquired in July 2017; partially offset by (iii) approximately \$66.0 million in sales attributable to an additional six days in fiscal 2016; (iv) approximately \$27.2 million in reductions from pricing, resulting from changes in customer and product mix, discounting and other items; and (v) approximately \$6.8 million from an unfavorable foreign exchange impact.
