CARD TO THE POLICE ACADEMY, LOCATED AT 130-30 28TH AVENUE, FLUSHING, NY, 2<sup>ND</sup> FLOOR, GYMNASIUM. THE CEREMONY WILL COMMENCE AT 1400 HOURS.

GUESTS WILL NOT BE PERMITTED TO ENTER UNTIL 1300 HOURS. IT IS REQUESTED THAT GUESTS BE SEATED BY 1345 HOURS TO ENSURE THE TIMELINESS OF THE CEREMONY. CARPOOLING IS ENCOURAGED DUE TO LIMITED PARKING.

IF THE OFFICE IS CLOSED, THE NOTIFICATION WILL BE MADE AT 0800 HOURS THE FOLLOWING DAY. MEMBERS OF THE SERVICE WILL STILL BE PROMOTED IF THEY ARE UNABLE TO ATTEND THE CEREMONY.
