

State Licensing for Perfusionists

Below is a complete list of states with perfusion licensing (or titling) requirements. All states have the following application requirements:

- Be at least 18 [21] years of age [NY]
- Be of good moral character
- Meet educational and examination requirements
- Submit information for previously/ currently held professional licenses
- File appropriate application
- Pay appropriate fee
- Some states have additional requirements such as:
 - Background check/ fingerprinting
 - Passport photos
 - National Practitioner Data Bank queries
 - Child abuse mandatory-reporting education (PA)
