Course description

This course will introduce students to the overall workings of a national economy. It will apply macroeconomic theory and principles to current economic issues at the national and international levels and examine their relationship to the economy of New York City, a center of international business. The course will cover a broad range of topics including money and the monetary system, income and expenditure, the role of fiscal and monetary policies in stabilizing the economy, the relationship between inflation and unemployment, and the role of government policy in promoting long-term economic growth. Students will be introduced to the methods economists use in economic analysis and research.

Pre/corequisites: MATH 120 or MATH 120.5 or equivalent

Learning Outcomes

- 1. Demonstrate an understanding of basic economic principles and their applicability to real-world issues, both domestic and international;
- 2. Describe, explain and evaluate economic conditions such as unemployment, inflation, government budgets, the balance of payments, income inequality and GDP growth using evidence from multiple sources and applying critical thinking skills;
- 3. Independently and in teams develop and communicate persuasive alternative oral and written explanations or solutions for contemporary macroeconomic issues;
- 4. Recognize macroeconomic theories and concepts in the media and their relation to other social issues and sciences;
- 5. Use graphs and algebra to analyze macroeconomic problems;
- 6. Describe and explain the relationship between economic functions such as savings and investment spending and their implications; and
- 7. Discuss and critique fiscal and monetary macroeconomic policies and their effects on the national economy.

Course Assignments

Participation (10%): You will demonstrate your engagement with the course by participating in discussion threads available in Brightspace. You are expected to post your own thread and reply to at least one another post from your peers.

Project (30%): The signature assignment for this course requires you to gather data about US unemployment rate, labor force participation, and non-farm payroll in the US in the past 50 years. You will analyze the data and propose possible economic explanations of your findings.

- Article name, date and where published including page number
- Book name, authors, publisher and year
- Link for websites used, including a brief annotation describing the website to demonstrate that this is

a valid and reliable source.

Whatever information you quote that is not generally accepted as fact (e.g., "Mexico is to the south of the United States") must be referenced. If you state, "in 2014 and 2015 Mylan increased EpiPen prices 32 percent each year", please remember to include an in-text citation such as (The New York Times, September 3, 2016) as well as in the references at the end of the paper. For the purpose of this course, you many not use Wikipedia as a reference.
