



Argentina increases import tariffs on 100 products

October 2014

Through Presidential Decree 1676, on October 7, 2014, the Argentine Government approved increased import tariffs on 100 Extra-zone “Non-Mercosur” origin products. The increases are a combination of modifications to Annex 1 of Decree 509 (dated May 15, 2007) and substitutions to the Annex of Decree 25 (dated January 22, 2013). The temporary tariff increases range between 10% and 35%, and affect a wide range of sectors, including food items, agricultural products and chemicals, consumer goods, manufacturing tools and equipment, and appliances.
