Main Street in Scranton, SC, as shown on Florence County Tax Map No. 00194, Block 03, Parcel 031 from Single Family Residential District (R-1) to Rural Community District (RU-1). (Deferred)
- PC#2018-03 Map Amendment requested by Florence County to change the zoning district designation for property located on W. Main St. in Timmonsville, SC as shown on Florence County Tax Map No. 70013, Block 01, Portions of Parcels 001 and 002 from Single Family Residential District (R-3) to General Commercial District (B-4).
