

Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. 1. **Eligibility:** The BOSE QC35 II Headphones - Week 14 (the "Sweepstakes") is open to all legal residents residing in the United States who are 13 years of age or older as of date of entry.
