

Waiver of Liability Form

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, herein referred to as COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person –to- person contact. As a result, federal, state and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people. SOBR (South Orlando Babe Ruth) has put in place preventative measures to reduce the spread of COVID-19; however, cannot guarantee that you will not become infected with COVID-19. Further, attending any events or activities at SOBR could increase your risk of becoming infected with COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I may be exposed or infected by COVID-19 while participating in any SOBR event or activity and that such exposure or infection may result in personal injury, illness, permanent disability and death. I understand that the risk of becoming exposed to or infected by COVID-19 at SOBR may result in actions, omissions, or negligence of myself and/or others, including but not limited to, SOBR volunteers, program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to myself (including but not limited to, personal injury, permanent disability and death) illness, damage, loss, claim, liability, or expense, of any kind, that I may experience or incur in connection with my participation at SOBR. On my behalf, I release, covenant not to sue, discharge and hold harmless the SOBR league, its volunteers, agents and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs and expenses of any kind arising out of or relating thereto. I understand and agree that this release includes Claims based on the actions, omissions, or negligence of the SOBR league, its volunteers, agents and representatives, whether COVID-19 infection occurs before, during or after participating in any SOBR events or activities.

In addition, I am aware that all non-field participants are required to wear a mask or other appropriate face covering at all times when on the property and voluntarily agree to do so.
