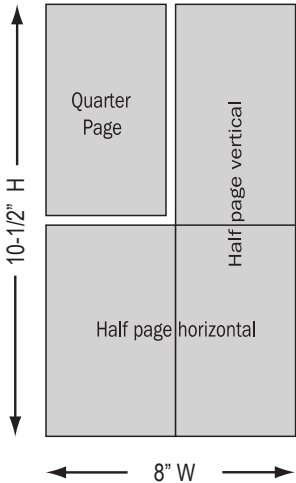

For Print-Ready Ads

- Submit ad files via email, USB or CD.
- All ad files MUST be submitted as a digital file.
- Ad must meet the exact dimensions as selected on the front of the form.
- File format must be JPG or PDF.
- Ad files must be high resolution.
- No web versions or pictures will be accepted as they are low-resolution and will not print properly.
- Please Note: Ads created with Word, PowerPoint, Publisher or Excel are NOT print-ready. You will need to pay production fees as outlined below under non-print-ready ads.)

For NON Print-Ready Ads

- We can assist in the production of print-ready artwork. Refer to the Production Charge Fee schedule below for basic ad preparation.
- Please submit an electronic soft copy of a logo and any other special symbols/artwork that needs to be exact or is copy-written like a corporate logo.
