

Orange Little League (OLL) Snack-Bar Buyout Volunteer Waiver and Release of Liability

The Volunteer desires to work as a buyout volunteer in the Orange Little League (OLL) Snack Bar. The Volunteer understands that the activities may include hours of standing, strenuous lifting, and other activities related to operating a Snack Bar.

WAIVER AND RELEASE I, the undersigned, hereby waive, release and discharge any and all claims or rights to claims for damages for illness, death, personal injury, and/or property damage which may accrue to me, as a result of my participation. This Release is intended to discharge in advance the promoters, sponsors, the Orange Little League, its Board members, other volunteers, the officials, its attorneys, insurers, agents, and any involved municipalities, school districts, or other public entities (and their respective agents and employees), hereinafter "Released Parties", from and against any and all liability arising out of or connected in any way with my participation, even though that liability may arise out of negligence or carelessness on the part of the persons or entities mentioned above.

INSURANCE Orange Little League does not carry or maintain, and expressly disclaims responsibility for providing any health, medical or disability insurance coverage for the Volunteer. EACH VOLUNTEER IS EXPECTED AND ENCOURAGED TO CARRY PERSONAL LIABILITY OR HEALTH INSURANCE PRIOR TO REGISTERING AS A BUYOUT VOLUNTEER FOR THE OLL SNACK BAR.

MEDICAL TREATMENT Except as otherwise agreed to by OLL in writing, Volunteer does hereby release and forever discharge OLL and all the Released Parties from any claim whatsoever that arise or may hereafter arise on account of any first aid, treatment or service rendered in connection with the Volunteer's work for OLL.

OTHER I understand that it is my desire to further the work of the OLL by performing services as a Volunteer, specifically as a Snack Bar Buyout Volunteer. I undertake to perform said services as a Volunteer without compensation and that, in performing said services, I acknowledge that I am not acting as an employee of Orange Little League and am not entitled to any Worker's Compensation coverage, and/or other benefits of an employee. The Volunteer expressly agrees that this Release is intended to be broad and inclusive as permitted by the laws of the State of California and that this Release shall be governed by and interpreted in accordance with the laws of the State of California. Volunteer agrees that in the event that any clause or provision of the Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of the Release which shall continue to be enforceable.
