

Montgomery County Senior Softball League 2018 Winter Indoor League Player Application

I, the undersigned player, acknowledge, agree and understand that: (1) voluntarily and of my own free will, I elect to participate as a member of the MCSSL; (2) I understand that there are certain risks and hazards involved in participating in softball, including, but not limited to those hazards associated with weather conditions, playing conditions, equipment, and other participants in addition to the acts of pitching, throwing, fielding and catching the ball, swinging the bat, running, jumping, stretching, sliding, diving, and collisions with other players, and with stationary objects, all of which can cause serious injury or death to me and to other players. Further, I agree that in consideration for the right to play as a member of the MCSSL and in consideration for permission to play on the fields arranged by the league: (3) I voluntarily elect and accept and solely assume all risks of damages, injury, including death, incurred or suffered by me:

(a) While practicing or playing as a member of the MCSSL;

(b) While serving in a non-playing capacity as a MCSSL member or observer during practice or play by other teams or by other players on my team; and

(c) While on the premises of any and all of the fields arranged for by my team or league for practice or play.

(4) I release, discharge and agree not to sue the team and/or the MCSSL or any owner or leasee of the fields on which softball is played or practiced by my team/league, the Amateur Softball Association of America or their owners, officers, agents, servants, associations, employees, or any person or entity connected with the team, league, field or Amateur Softball Association of America for any claim, damages, costs or cause of action which I have or may have in the future as a result of injuries or damages sustained or incurred by me from whatever cause including but not limited to the negligence, breach of contract, or wrongful conduct of the parties hereby released. I further agree that I shall hold harmless and fully indemnify the parties hereby released from any claims, damages, costs, including attorney fees, and cause of action which may arise from any claim or cause of action made by me, through me or on my behalf even if the damages, injuries or death are caused in whole or in part by any of the parties or entities hereby released.

I acknowledge that I have read and understand each and every one of the above provisions in the player waiver, release of liability, and indemnification agreement and agree to abide by them.
