## 2018 TOURNAMENT AFFIDAVIT ROSTER FORMS AND INSTRUCTIONS

**CREDENTIALS MEETING** - Your District Director will notify you about the time, place and date for the **2018 District Credentials Meeting** to verify tournament credentials for DYB tournament play. Below are instructions to register and qualify your league's 2018 tournament teams in all age divisions. **Every tournament team must create a DYB Tournament Affidavit roster form online for each age division and print and bring three signed originals to the District Credentials Meeting. Tournament rosters must be created on the Manage Teams page in the Baseball 2018 Allstars session. Only players who are on regular season rosters in the SI Play database may be selected for the league all-star tournament teams.**

To create tournament rosters from your SI Play league Manage Teams page to bring to the District Credentials Meeting, your roster admin should login to your league Manage Teams page. In addition to the roster forms, each team shall bring to the District Credentials Meeting the **player birth certificates, proof of insurance coverage** (as specified in **Tournament Rule II(C)(1) and II(C)2 Page 87**) and a **medical release form**. Closely, follow the instructions below to ensure the eligibility of your 2018 tournament teams in each age division.

**IMPORTANT: All State Tournament Host team coaches must attend the District Credentials Meeting.**

**TOURNAMENT TEAM ROSTERS** - Three original Tournament Eligibility Affidavits/Rosters must be signed by the league president and taken to the District Credentials Meeting. Notarization of the Affidavit/Roster is not required. The Tournament Team Affidavit/Roster form can be completed online by doing the following:

- 1) Log on to your SI Play LEAGUE Manage Teams Page at <https://login.siplay.com/Users/Login>.
- 2) Click the **Get Started** link on the home page or the **Manage Teams** link in the left navigation panel.
- 3) **Select the Baseball 2018 All Stars session in the dropdown window.**
- 4) **Select the appropriate age Division.**
- 5) **Click on +Add an All-Star Team link on the right side of the page and enter team name.**
- 6) **Confirm Age Playing Division and Franchise Number and Save team.**
- 7) **If the player does not have full name and correct birth date, you will have to edit their regular season roster for their corrected information to display on the official tournament affidavit..**
- 8) **Assign Players to Tournament Team-** including one (1) Manager and Coaches to tournament teams.
  - a. Click on Edit Roster to add players and coaches.
  - b. Click on **Add Volunteers** to select coaches on regular season rosters for tournament roster. **One coach must be designated as Manager. The other coaches must be designated as Coach.**
  - c. Click on Players division in left panel navigation and then click on **Add Players.**
  - d. Select Available Players by check box next to names and then click **Assign to Team.**
  - e. Once you have the appropriate number of players and coaches, submit the team.
- 9) Sanctioned DYB Majors, "O"Zone, and AAA tournament teams must have affidavits with 12 players and three coaches (**Four coaches are required for AA and A Divisions**).
- 10) **Repeat steps for each tournament team in other age divisions.**
- 11) **After your rosters are completed, they may be printed as detailed in the instructions.**
- 12) **IMPORTANT! Print a copy of each roster and compare to birth certificates before printing copies for the District Credentials Meeting.**
- 13) **Finally, print three (3) copies of your tournament roster to take to District Credentials Meeting.**
- 14) **Print a copy of the Pitching Record to attached to your copy of the Tournament Roster.**
- 15) Please email [support@siplay.org](mailto:support@siplay.org) or [support@dixie.org](mailto:support@dixie.org) if you need assistance with tournament rosters.

**BIRTH CERTIFICATES** - A signed statement by a parent that the player's **birth record** is an authentic copy of an original birth record if the original birth certificate is not presented. Also required is a completed **Medical Release Form** listing each player with parent signature next to each player's name. **CAUTION!!** *Only players registered in the league on Player Registration Forms in the DYB Online Roster database are eligible for that league's tournament team.*

**MEDICAL RELEASE FORMS** - All twelve (12) players should be listed on the **Medical Release Form** with the signature of a parent or legal guardian on the line beside the player's name. Attach this form to the **Tournament Eligibility Affidavit** and submit it for approval with the birth record for each player at the credentials meeting. If a parent refuses to sign the Medical Release Form, another player should be chosen unless the parent submits a signed written explanation to the Commissioner for final approval or rejection. A form is enclosed but you can download more from the Dixie website by clicking on the **Online Rosters** tab and clicking on **Medical Release Form** to download a printable form.

**INSURANCE COVERAGE** – Each tournament team must present satisfactory evidence of **BOTH accident and liability insurance coverage** to participate in DYB tournament play. The league's general liability insurance policy/certificate of coverage will name Dixie Youth Baseball, Inc. as an "**additional insured**". See **Tournament Rule II(C)(1)(2) Page 87**.

**PLAYER REPLACEMENT** - If a player is lost to the team permanently after the original Tournament Eligibility Affidavit has been submitted and approved by the Credentials Committee at the District Credentials Meeting, please refer to **Tournament Rule VI (A) (Page 92)** for procedures to follow to get a replacement player approved as quickly as possible. It is suggested that each player who is selected to participate on a tournament team and the player's parents should be contacted before the affidavit is completed to assure he is available and will actively participate in every tournament practice and game. **REMEMBER, Dixie Youth does not recognize the selection of alternates.** If a league selects additional players for possible player replacements, the player and his parents should not be informed until he is officially added to the team in order to avoid the expectation of privileges granted members of the official tournament team roster.

**PITCH COUNTS – All pitchers will be subject to Pitch Count Rest Period Restrictions. Please review in the Tournament Pitching Rules Section VII (Pages 92-94).**

**PLAYER PARTICIPATION REQUIREMENT** - Refer to the player participation requirement in **Tournament Rule IX (Page 95-98)**. At a minimum, all players must bat at least once and play on defense for three consecutive outs during each game throughout tournament play. However, we encourage managers to play all players as much as possible beyond these minimum requirements. All team members should be competitive players to have been selected for the DYB tournament team. **Penalty: The penalty for violation of IX(A)(1) shall be the disqualification of the team manager for the remainder of the game and the remainder of the next game played by his team in the tournament or series.**

---

### Create Tournament Affidavit/Rosters for District Credentials Meeting

To begin the Tournament process, you must first logon to your SI Play league home page at <https://login.siplay.com/Users/Login/> . **Remember:**

1. You must print three originals, sign them and bring to the District Credentials Meeting.
2. **Manually rosters are not acceptable. All rosters must be created online.**
3. Only Players on Regular Season rosters can be selected to All-Star teams.
4. If a Manager or Coach is not listed on a regular season roster, you will have to add to a regular season team before he can be added as a tournament coach.
5. Also, bring player birth certificates and medical release for for each team to District Credentials Committee.
6. Contact [support@siplay.com](mailto:support@siplay.com) or [support@dixie.org](mailto:support@dixie.org) if you need assistance in completing your tournament rosters.

### Create Tournament Teams

To begin the Tournament process, you must first create teams in your All Star Session. To do this:

1. On the left hand side of the screen, go to **Teams > Manage Teams**.
2. Choose your **2018 All-Star Baseball** Session from the dropdown.
3. Click **+ Add New Team** in the top right corner of the screen.
4. Enter your Team Name and choose the appropriate division from the dropdown.
5. Select whether or not this team should be submitted to Dixie Youth Baseball.
  - If the team is a franchised team, select **Yes** from the dropdown.
  - If this team should **not** be submitted to Dixie Youth Baseball, select **No, this is a Private Team**.
6. Once complete, click **Save**.
7. Repeat steps 1-6 for each team in your All Star Session.

### Roster Players and Volunteers

Following the creation of your Tournament Teams, you will then add your players and volunteers.

To assign players/volunteers (registrants) to your team:

1. Be sure you are on **Teams > Manage Teams**.
2. Select the team to which you would like to assign players/volunteers.
3. Toward the top of the screen, select **Edit Roster**.
4. To add players and/or volunteers, select **+Add Players** or **+Add Volunteers**.
5. On the left, you should now see a panel named **Available Registrants**.
6. Select the correct regular season division to choose your registrants.
7. Select the players and/or volunteers you would like to assign to your team.
8. Then click **Assign to Team** at the bottom of the Available Registrants panel.
9. You should now receive a pop-up requesting confirmation of the team assignment.

1. The risk of injury to my child/ward from the activities involved in these programs is significant, including the potential for permanent disability and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,
2. I, FOR MYSELF, SPOUSE, AND CHILD/WARD, I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my child/ward's participation; and,
3. I willingly agree to comply with the program's stated and customary terms and conditions for participation. If I observe any unusual significant concern in my child/ward's readiness for participation and/or in the program itself, I will remove my child/ward from the participation and bring such attention of the nearest official immediately; and,
4. ## IMPORTANT NOTICE TO LEAGUES ABOUT INSURANCE REQUIREMENTS IN DYB RULEBOOK

**Dixie Youth Tournament Rules, II Financial Responsibility - Page 87, (C) Tournament Host And Team Insurance For Sanctioned Tournaments** requires that all teams participating in sanctioned and other approved DYB tournament play must provide evidence of Accident and General Liability insurance that meets certain minimum standards as follows:

- (1) **Excess Accident** – The Tournament Host and each tournament team must be covered by an Excess Accident policy under their respective organizations’ name with a medical limit of at least \$50,000. For teams, it is not acceptable for each parent to provide individual evidence of health insurance for his or her child. For the tournament host, coverage must be provided for all umpires, scorekeepers, employees and volunteers; and
- (2) **General Liability** – The Tournament Host and each tournament team must be covered by a General Liability policy under their respective organizations’ names with an “each occurrence” limit of at least \$1,000,000 combined single limits for “bodily injury” and “property damage”. Such policy may not provide “claims made” coverage and may not have exclusion for lawsuits arising out of injuries to athletic participants. If the tournament host or team does not purchase its General Liability insurance through the approved Dixie Youth Baseball, Inc. insurance program (see rule book advertisement), it is required that the General Liability policy name Dixie Youth Baseball, Inc. as and “additional insured”.

Dixie Youth Baseball recommends that leagues purchase their Accident and General Liability insurance from the endorsed DYB program through Sadler Sports Insurance. The endorsed DYB program automatically meets all minimum insurance requirements and as a result does not need to be closely scrutinized by the tournament credentials committee.

**However, if both Accident and General Liability are not purchased through the endorsed DYB program:**

- 1) The league should request that their insurance agent complete the checklist on the reverse side of this page to verify compliance with the minimum standards. If 100% of standards are not met, the tournament credentials committee will not accept the insurance for entry into the DYB sanctioned or approved tournament.
- 2) This completed and signed checklist should be presented to the tournament credentials committee with evidence of Accident and General Liability insurance to expedite their review.
