## **Uniform Replacement Agreement and Refund Policy**

### **Fee and Insurance Agreement**

**Registration fee for the 2019 season is \$475. Any additional family member players are \$425. Entire fee must be paid in full *and/or payment plan established with the ALC Treasurer prior to the first practice.* Refund is 100% up to the first practice. After the first practice, no refund will be issued due to injury, academic eligibility or relocation.**

**Our goal is not let finances prevent any player from being on the team. While we need to charge player fees and fundraise in order to fund operations and remain solvent, please do not let lack of financial means prevent your player from being part of the team. Please indicate that you will need a payment plan and work to pay back the player fees over time.**

Medical insurance is required of all players on the Aloha Lacrosse Club Varsity team. It is understood that the Aloha Lacrosse Club Varsity team is not liable for any medical, dental, hospital bills, or ambulance charges occurring as a result of injuries incurred while participating in this club sport including conditioning and that such bills in excess of the players insurance benefits, [shall be the responsibility of the player and/or his parents.](#)

## **US Lacrosse Membership**

Participation in the Aloha Lacrosse Club is **no longer** contingent on each player holding a current US Lacrosse membership. Aloha Lacrosse Club is purchasing insurance to cover the team directly and will **not** enroll and pay for your US Lacrosse Membership. Note that players involved in other leagues (e.g. indoor, select) or refereeing may need to procure US Lacrosse Membership on their own.

## **Verification of Tualatin Hills Parks & Recreation Membership Number**

A current in-district THPRD membership is required. If the player's residence is out-of-district, all out-of-district fees will be applied through THPRD. Proof of fees paid must be submitted. This is a requirement of Tualatin Hills Park and Recreation District affiliate policy. Aloha Lacrosse Club will cover your out-of-district assessment.

## **Academic Eligibility Agreement**

All players of the Aloha Lacrosse Club Varsity team are required to be academically eligible and conform to the rules of scholastic eligibility, participation and training rules as prescribed by the Oregon School Activities Association which are adhered to by the Oregon High School Lacrosse Association.

Eligibility is based on the following: **GPA of 2.0 containing no F's**. GPA enforcement is each parents responsibility.

## **Transportation Agreement**

Players & parents are responsible for their own transportation arrangements to and from all regular season practices and games. Most regular season games and practices are within the Portland Metro area. Arrangements & permission for any mass transportation required for out of region playoff games will be handled as the need arises.

2. I give consent to the Aloha Lacrosse Club, coaches and staff and/or any host organization of US Lacrosse, Beaverton School District and/or THPRD, to provide through a medical staff of its choice, customary medical/athletic training attention, transportation and emergency medical services as warranted in the course of my participation in US Lacrosse and ALC sanctioned events.
3. The risk of injury to my son from the activities involved in lacrosse exists and there is the potential for permanent disability and death, and while particular rules, equipment, and personal discipline reduce this risk, the risk of serious injury does exist; and,
4. MY SON, SPOUSE AND I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, and assume full responsibility for my son's participation; and
5. I willingly agree to comply with ALC's stated and customary terms and conditions for participation. If I observe any unusual significant concern in my son's readiness for participation and/or in the program itself, I will remove my son from the participation and bring such attention to the nearest official immediately; and,
6. On behalf of myself, spouse and son, I HEREBY RELEASE, HOLD HARMLESS AND AGREE TO INDEMNIFY Aloha High School, Beaverton School District, Tualatin Hills Parks and Recreation District, its playing sites, event organizers, coaches, officials, landlords, ALC Board of Directors and staff, officers, officials, agents, employees, volunteers, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("Releasees"), with respect to any and all injury, disability, death, or loss or damage to person or property incident to my son's involvement or participation in all ALC events, activities, practices and games, whether arising from the negligence of the Releasees or otherwise; to the fullest extent permitted by law.
