Fall 2020 to Spring 2021 Season (July 1, 2020 – June 30, 2021)
Parent Permission Form, Liability Waiver and Release, and
Authorization for Medical/Dental Treatment

I, the undersigned and the parent and/or legal guardian of _____ (“Player”), acknowledge that the Player is receiving valuable instruction and experience by her involvement with the Pinnacle Girls Lacrosse Club (PGLC). In consideration thereof, I hereby grant permission for the Player to participate as a member of PGLC, including but not limited to practices, games, tournaments, clinics, camps, fundraising, volunteering, social activities, travel by any and all means including public, private, and commercial transport by ground, air, and water based vessels, and any other activities sponsored by PGLC. I recognize that girls’ club lacrosse is a contact sport and that serious injuries can and do occur. I accept the full responsibility for any injuries that may occur to the Player as a result of her participation in the PGLC program. I attest that the Player is in good health, is physically fit, and is able to participate in the normal activities of lacrosse. I am aware that PGLC encourages each player to have a complete physical performed by a physician prior to participating in team practices, games, or activities, and it is my responsibility to ensure that a physical examination is completed.

The novel coronavirus, SARS-CoV-2 and the disease that results from infection, COVID-19, has been declared a worldwide pandemic by the World Health Organization. SARS-CoV-2 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people. PGLC is following the guidance given by the Center for Disease Control, the Arizona Interscholastic Association, U.S. Lacrosse and other federal and state agencies and has put in place preventative measures to reduce the spread of SARS-CoV-2 and COVID-19 consistent with the latest recommendations from those entities; however, PGLC cannot guarantee that the Player, parent, guardian or any spectator will not become infected by SARS-CoV-2. Further, attending PGLC activities could increase the risk of contracting COVID-19. I acknowledge the contagious nature of SARS-CoV-2 and COVID-19 and voluntarily assume the risk that I may be exposed to or infected by SARS-CoV-2 by attending PGLC activities and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by SARS-CoV-2 may result from the actions, omissions, or negligence of myself and others, including, but not limited to, PGLC employees, volunteers, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to Player, myself, and others claiming through me or the Player, including, but not limited to, personal injury, disability, and death, illness, damage, loss, claim, liability, or expense, of any kind, that I, or anyone claiming through me or the Player, may experience or incur in connection with my or Player’s participation in PGLC activities (“Claims”). I waive any and all liability against PGLC, including without limitation its officers, board of directors, employees, coaches, trainers, volunteers, affiliated organizations, sponsors, vendors, suppliers and any school, school district, owners or operators of any facility utilized by the PGLC (collectively the PGLC Parties), and hereby release and discharge the PGLC Parties from any claim, loss, injury, cost, damage, or expense incurred by or on behalf of the Player as a result of the Player’s participation in the PGLC program. I hereby further agree to indemnify, defend, and hold harmless all of the PGLC Parties for and from any judgment awarded, attorneys’ fees, and any other expenses with respect to any Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on

the actions, omissions, or negligence of a PGLC Party, whether a SARS-CoV-2 infection occurs before, during, or after participation in any PGLC activity.

I, the undersigned and the parent/guardian of Player, hereby grant permission for PGLC, its officers, employees, coaches, and trainers to authorize medical or dental treatment of the Player by any available and qualified physician, dentist, or other trained medical personnel. This permission extends to and includes authorization for emergency treatments, procedures, and surgeries for the Player. Furthermore, ongoing medical treatment is authorized until such time as the undersigned shall dismiss these physicians, dentists, or medical personnel in writing and have engaged another qualified physician. This permission and authorization includes admission to a hospital facility if the attending physician deems it necessary. The permission for participation and authorization for medical treatment is effective for the 2020 lacrosse season which includes all preseason practices and pre-season play ("Participation Period"). The waiver and release of liability for causes of action arising under or related to the Participation Period continues into perpetuity.

I agree that all photographs, either still or moving, taken of Player by PGLC during her participation in PGLC activities are owned solely by PGLC, and PGLC may copyright material containing the same in whole or in part. I agree that PGLC has the right to use these photographs for commercial (including without limitation publicity, promotion, and advertising) and non-commercial use without restriction and without payment of any compensation. I also grant PGLC the nonexclusive, perpetual, worldwide right, without further consideration, to use, copy, publish, reuse, or display any quote, personal statement or other testimonial given by me in connection with PGLC, whether given orally or in writing, in whole or in part, without restrictions, for any purpose, whether commercial or noncommercial, in any media. I further consent to the use of any printed material in connection therewith. I further understand that these pictures, videos, and or statements may appear on the PGLC website (www.pinnaclegirlslacrosse.com), on the Arizona Girls Lacrosse Association website (www.azgla.com), or other associated lacrosse/sports websites.

I understand that participation in PGLC is done in accordance with the acceptance of this permission, authorization, release and waiver.
