- I understand that if my son/daughter's original picture, **COPY** of birth certificate, registration and medical form are not on file by August 1, 2019, or by the day they should start, he/she **WILL NOT** be able to participate in practice until **ALL documents** have been received.

FOR CHEER PARENTS ONLY: ATTENDANCE POLICY

- I understand that my child cannot miss more than **3 absences between August 1st and September 1st.**

As of September 1st through the last competition date, each athlete will have 1 unexcused absence which can be used at your discretion. ***Please note, you will not be able to use this 1 unexcused absence 2 weeks prior to Competition.*** If your child misses more than the 1 practice, the Hawks may remove your cheerleader from a stunt group if necessary.

2 Excused Absences will be allowed with a doctor's note.

If any more absences occur the Hawks may remove your cheerleader from a stunt group.

Competitions may not be missed, (unless the athlete does not wish to participate, and/or without prior approval) and if your child will not be at a competition, **they will be removed from a stunt group regardless of the reason.**

****This attendance policy is put into place so that all athletes are participating at the same commitment level.
