WAIVER AND RELEASE OF LIABILITY AND ASSUMPTION OF RISK AND PARENTAL CONSENT AND INDEMNITY AGREEMENT

In Consideration of my Child being allowed to participate in any way in the Pacific Inline Hockey League, I agree and acknowledge:

1. I understand the nature of Hockey activities and acknowledge: My Child's experience and capabilities and believe he/she is qualified to participate in such activity. I further acknowledge that I am aware that the activity will be conducted in facilities open to the public during the activity. I further agree and warrant that if, at any time, I believe conditions to be unsafe, I will immediately discontinue participation in the activity.
2. I FULLY UNDERSTAND that: (1) Hockey activities involve risks and dangers of SERIOUS BODILY INJURY, PERMANENT DISABILITY, PARALYSIS AND DEATH ("Risks"); (2) these Risks and dangers may be caused by my Child's own actions, or inactions, the actions of others participating in the activity, the condition in which the activity takes place or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (3) there may be other risks and social and economic losses either not known to me or not readily foreseeable at this time and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND RESPONSIBILITY FOR LOSSES, COSTS AND DAMAGES incurred as a result of participation in the activity.
3. I HEREBY RELEASE, DISCHARGE, CONVEYANT NOT TO SUE, AND AGREE TO HOLD HARMLESS Pacific inline Hockey, their respective administrators, directors, members, agents, officers, officials, volunteers, and employees, and all other participants, any sponsors, advertisers, and if applicable, owners and lessors of the premises on which the activity takes place (each considered one of the "Releasees" herein) from all liability, claims, demands, losses or damages on account caused or alleged to be caused in whole or in part by the negligence of the "Releasees" or otherwise, including negligent rescue operations and further agree that if, named above, I WILL INDEMNIFY, SAVE AND HOLD HARMLESS EACH OF THE RELEASEES FROM ANY LITIGATION EXPENSES, ATTORNEY FEES, LOSS LIABILITY, DAMAGE OR COST AS MAY INCUR AS THE RESULT OF ANY SUCH CLAIM.
4. I also irrevocably authorize Pacific Inline Hockey and any licensee or assignee to use my name and or likeness without compensation, in photography, video or any other format for publication, sale production, advertising in connection therewith, or any other use.

I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I AND THE MINOR HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY AND WITHOUT ANY INDUCEMENT OR ASSURANCE OF ANY NATURE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY THE LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID THAT THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT.
