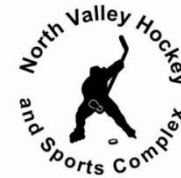

Consent and Liability Waiver – Release of all claims (must be signed to participate)

I, _____ am an adult participant or the parent/legal guardian, of _____, a minor child participant in an Indoor Sports League, Program, Camp, Clinic or Other Activity (hereinafter collectively referred to as "Activities") at the North Valley Hockey & Sports Complex facility at 250 Walsh Street, Hamilton City, California. As lawful consideration for said participation, I agree that neither I nor my minor child will make a claim against, sue, attach the property of or prosecute North Valley Hockey & Sports Complex Corporation, and their agents, sponsors, building contractors, suppliers, and employees (hereinafter collectively referred to as "NVHSC") for damages for death, personal injury or property damage which I or my minor child may sustain as a result of participation in "Activities". This release is intended to discharge in advance "NVHSC" from and against any and all liability, including for negligent actions, arising out of or connected in any way with participation in "Activities" except for liability that may arise out of the willful or wanton misconduct of "NVHSC".

I further understand that sports involve physical contact between players, that serious accidents occasionally occur during sports and participants in sporting activities occasionally sustain serious personal injuries (including death) and/or property damage as a consequence thereof. Knowing the risks of participation, I nevertheless hereby agree that I and my minor child assume those risks and release and hold harmless "NVHSC" who, through negligence or carelessness, might otherwise be liable to me, my minor child or our heirs or assigns. I attest that I am eighteen (18) years old or older, and that I or my child, as applicable, is physically fit and has no known medical conditions which prohibit participation in this sports activity. My child and I agree to follow all laws, rules and guidelines regulating the conduct of said sports activity. I also understand and agree that I am responsible for the mechanical and/or operating condition of any and all sports equipment used by me or my child and I agree that my child and I will continuously inspect all equipment used, maintain personally owned equipment and immediately return "NVHSC" provided equipment to "NVHSC" when maintenance is necessary.

I HAVE CAREFULLY READ THIS AGREEMENT AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY FOR MYSELF AND MY CHILD AND A CONTRACT BETWEEN MYSELF, MY CHILD AND "NVHSC", AND I HAVE SIGNED IT OF MY OWN FREE WILL.
