

### Minor Waiver and Release of Liability

In consideration of being allowed to participate in any way with the Memorial Girls Lacrosse Club, and all related events and activities, the undersigned:

1. Agree that the parent(s) and/or legal guardian(s) will instruct the minor participant that prior to participating she should inspect the facilities and equipment to be used, and if anything is believed to be unsafe, immediately advise her coach or supervisor of such conditions so that they may be rectified.
2. Acknowledge and fully understand that each participant will be engaged in activities that involved risk of serious injury, including permanent disability or death, which might result not only from their own action, inaction or negligence, but also the action, inaction, or negligence of others; the rules of play; the condition of the premises or any of the equipment being used.
3. Assume all foregoing risk and accept personal responsibility for the damages following such injury, permanent disability, or death.
4. Release, waive, discharge, and covenant not to sue the Memorial Girls Lacrosse Club, Spring Branch Independent School District, Memorial Senior High, Texas High School Girls Lacrosse League, United States Lacrosse, and all affiliated or non-affiliated teams, clubs, their respective administrators, directors, agents, coaches, and other employees of the organization, other participants, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessors of the premises used to conduct the event, all of which are hereinafter referred to as "releasees," from any and all liability to each of the undersigned, his or her heirs and next of kin and all claims, demands, losses, or damages on account of injury, including death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the releasees or otherwise.
5. Agree that the parent(s) and/or legal guardian(s) will instruct the minor participant to only participate in Memorial Girls Lacrosse Club games, practices or activities that they believe they are physically and psychologically prepared to participate.
6. I hereby grant to Memorial Girls Lacrosse, its coaches, parents, Booster Club VPs or any other agent acting in its best interests, the right to use my/my daughter's image for the purpose of broadcast, lacrosse program promotion, and/or distribution of team pictures and fliers, whether they be for online publication, tv / newspaper / magazine media, or for posting team fliers in stores or restaurants. It is also understood that any such materials (picture, video, audio, and any other form of media) will be used with the highest integrity and discretion, with the intent to communicate and promote Memorial Girls Lacrosse responsibly and ethically.
7. I have read, understand and agree to be bound by the expectations and requirements set forth in the Memorial Girls Lacrosse Club Policy Manual. I also recognize that failure to follow such policy may, depending on the violation, result in my dismissal from the Memorial Girls Lacrosse Club for a period or permanently.
