RETURN TO PLAY WAIVER

In consideration of being allowed to participate in any way in Woburn Little League and all its related events and activities, the undersigned acknowledges, appreciates, and agrees that:

1. The risk of injury and/or illness from the activities involved in any athletic endeavor is possible, and while particular rules, equipment, personal discipline and the utmost care and precautions taken by Woburn Little League may reduce the risk, the risk of injury/illness does exist;
2. The risk to have contact with individuals, who have been exposed to and/or have been diagnosed with one or more communicable diseases, including but not limited to COVID-19 or other medical conditions, diseases, or maladies does exist, and despite Woburn Little League's precautions it is impossible to completely eliminate the risk that I or my child could be exposed to and/or become infected through contact with or close proximity with an individual with a communicable disease;
3. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume all full responsibility for my participation;
4. I willingly agree to comply with the stated and customary terms and conditions for participation and all restrictions and precautions implemented by Woburn Little League regarding the COVID -1 pandemic . If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself and my child from participation and bring such to the attention of the nearest official immediately; and
5. I, for myself and on behalf of my children, my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS WOBURN LITTLE LEAGUE their officers, officials, agents and/or employees, board members, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of the premises used to conduct the event ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, ILLNESS, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, including but not limited to COVID-19 exposure.
6. **I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, BEFORE ACKNOWLEDGING THE CHECKBOX BELOW, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY AGREEING TO IT ON MY OWN BEHALF OR ON BEHALF OF THE YOUTH PARTICIPANT ASSOCIATED WITH THIS GUARDIAN ACCOUNT, AND I SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.**
