Terms & Conditions

- A. Athletic training can result in serious injury, including, but not limited to, paralysis, dismemberment, permanent disability and death. By entering into this agreement, Member agrees to release us and RedLine Athletics Franchising LLC, and its respective owners, employees, servants, agents, or anyone else connected with us or RedLine Athletics Franchising LLC for injuries received, and Member assumes for himself or herself, all risk of injuries to his or her person while receiving training services hereunder, whether or not caused by any act on the part of an employee, agent, servant, or other person affiliated with us or RedLine Athletics Franchising LLC, through defective apparatus or equipment, or failure to warn as to proper use or danger of such apparatus or equipment, or of our or RedLine Athletics Franchising failure to repair or replace any defective apparatus or equipment. Member agrees to indemnify and hold us and RedLine Athletics Franchising or any of our respective employees, servants, agents, or anyone else connected with us or RedLine Athletics Franchising, harmless from any claims, damages, costs or causes of action that such Member has or may have as a result of any injury, damage or loss sustained while receiving any service(s) provided by or through us or any other RedLine Franchisee or affiliate of RedLine Athletics Franchising LLC pursuant to this Agreement.
- B. Membership may be revoked at any time for failure to abide by the Terms and Conditions of Membership, and we, reserve the right to discontinue service to any Member that fails to abide by the terms of membership.
- C. To cancel a **Month to Month Agreement** the member must notify their training center in writing 30 days in advance. The member is responsible for any bill dates that fall within those 30 days and will be granted access for the 30 days following the final bill date.
- D. To cancel a **12 Month Agreement** prior to the fulfillment of the term, the member is required to pay 25% of the remaining balance at the time of cancellation. Half of this amount may be applied towards a new membership if the member chooses to return in the future. If a 12 month member wishes to cancel their agreement after the term 12 month term is fulfilled, they must notify their training center in writing 30 days in advance. The member is responsible for any bill dates that fall within those 30 days and will be granted access for the 30 days following the final bill date.
- E. We, or any trainer at our facility, reserves the right to deny or refuse to re-enroll any Member who has failed to remit his or her membership payment(s) in a timely manner, or who has engaged in conduct in violation of any term or condition of this Membership Agreement.
- F. Members are financially responsible for all membership dues and related fees. We, on our own or through our designee, reserve the right to collect any and all delinquent dues or fees owed by a Member. If a Member becomes delinquent in payment of his or her dues or fees, we, on our own or through our designee, reserve the right to refer such Member to a collection agency and Member shall be required to pay all reasonable collection costs associated with the collection of such unpaid dues or fees. Member agrees to notify us of any changes in Member's personal information in this Agreement, including mailing address, telephone number and credit or debit card information. Member's failure to report such changes in a timely manner may constitute grounds for termination of Member's membership.
- G. Neither we nor RedLine Athletics Franchising or any RedLine Athletics affiliate or franchisee is responsible for lost or stolen articles or goods while Member is present at a training center operated or managed by us, or a RedLine Athletics affiliate or franchisee.

The laws of the state of Oregon will govern the validity of any of the terms and provisions of this Agreement as well as the rights and duties of the parties.
