

COVID-19 AFFIDAVIT AND AGREEMENT

The health and safety of our athletes, staff, and volunteers remain our highest priority. Below, you will find a summary of actions we are taking to help ensure we are lowering COVID-19 risk as much as possible while also allowing our athletes to play. We are:

- Doing temperature checks for all athletes and volunteers at the start of every practice. Anyone with a temperature of 100° or more will be sent home
- Intensifying cleaning and disinfection within our facilities and premises by cleaning and disinfecting the bathrooms and gate entrances to the practice field before and after every practice, and ensuring safe and correct use and storage of disinfectants
- Reducing physical closeness or contact between players when possible by keeping children in small groups, putting signs on playing fields to ensure that cheerleaders belongings and water bottles are kept apart at a safe distance, reminding coaches and players to stay 6 feet apart, and discouraging unnecessary physical contact
- Promoting healthy hygiene practices by providing hand sanitizer before, during, and after practices and encouraging children to cover coughs and sneezes with a tissue or to use the inside of their elbow
- Masks are optional and allowed for athletes and volunteers

To protect the athletes, families and our volunteers, you and your child must agree to the following terms or will be sent home. **Any individual who is sent home twice for violating these rules, will not be permitted to return.** By signing below you and your child confirm your current health status and agree to follow the rules listed below.

- > I, nor any member of my family, have not experienced symptoms that of fever, fatigue, difficulty in breathing, or dry cough or exhibiting any other symptoms relating to COVID-19 or any communicable disease within the last 14 days.
- > I have not, nor any member(s) of my household, traveled by sea or by air, internationally within the past 30 days.
- > I have not been, nor any member(s) of my household, diagnosed to be infected of COVID-19 virus within the last 30 days.
- > All athletes must bring their own water, clearly labeled with their name and must not share with anyone. Concession will NOT be open to buy or refill waters.
- > Athletes can only bring necessary items to practice, ie. water, phone, towel, bug spray
- > Athletes must keep their belongings separated by 6' or more in designated areas. Social distancing must be adhered to during water breaks.
- > No more than 2 athletes may go to the bathroom at the same time.
- > Parents must also adhere to the 6' social distancing guidelines. No one may sit on the bleachers. We're recommending parents wait in cars during practice or drop off/pick up only. If a parent chooses to stay, they must bring a chair and sit 6' away from anyone else.

WAIVER/RELEASE FOR COMMUNICABLE DISEASES INCLUDING COVID-19

ASSUMPTION OF RISK / WAIVER OF LIABILITY / INDEMNIFICATION AGREEMENT

In consideration of being allowed to participate on behalf of Fishhawk Wolfpack Cheer Association's athletic program and related events and activities, the undersigned acknowledges, appreciates, and agrees that:

1. Participation includes possible exposure to and illness from infectious diseases including but not limited to MRSA, influenza, and COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist; and,
2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and,
3. I willingly agree to comply with the stated and customary terms and conditions for participation as regards protection against infectious diseases. If, however, I observe and any unusual or significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and,
4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS Fishhawk Wolfpack Cheer Association their officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("RELEASEES"), WITH RESPECT TO ANY AND ALL ILLNESS, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IF FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
