In the event no one listed above be reached, I hereby give my permission to the licensed health-care practitioner selected by the coach, assistant coaches or parents of team members acting in the capacity of activity supervisors/vehicle drivers, as my agents to secure proper treatment, including hospitalization, anesthesia, surgery, or injections of medication for my child.

Waiver of Liability, Assumption of Risk, and Indemnity Agreement

Waiver: In consideration of your child being permitted to participate in any way in Bella Vista High School Boys Lacrosse Association activities, clinics and camps, I as a the parent or legal guardian, my heirs, personal representatives or assigns, do hereby release, waive, discharge, and covenant not to sue Bella Vista High School Boys Lacrosse Association, its staff, contractors, officers and directors due to any personal injury, accidents (including death), illnesses and property loss arising from participation in the Bella Vista High School Boys Lacrosse Association activities, clinics and camps including any negligence of the Bella Vista High School Boys Lacrosse Association, its staff, contractors, officers and directors.

Assumption of Risks: Participation in Bella Vista High School Boys Lacrosse Association activities, clinics and camps carries with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. The specific risks vary from one activity to another, but the risks range from 1) minor injuries such as scratches, bruises, and sprains to 2) major injuries such as eye injury or loss of sight, joint or back injuries, heart attacks, and concussions to 3) catastrophic injuries including paralysis and death.

Indemnification and Hold Harmless: I also agree to indemnify and hold the Bella Vista High School Boys Lacrosse Association and its staff, contractors, officers and directors harmless from any and all claims, actions, suits, procedures, costs, expenses, damages and liabilities, including attorney’s fees brought as a result of my involvement in Bella Vista High School Boys Lacrosse Association activities, clinics and camps and to reimburse them for any such expenses incurred.

Severability: The undersigned further expressly agrees that the foregoing waiver and assumption of risks agreement is intended to be as broad and inclusive as is permitted by the law of the State of California and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

Acknowledgment of Understanding: I have read this waiver of liability, assumption of risk, and indemnity agreement, fully understand its terms, and understand that I am giving up substantial rights, including my right to sue. I acknowledge that I am signing the agreement freely and voluntarily, and intend by my signature to be a complete and unconditional release of all liability to the greatest extent allowed by law.
