



Return to Play Waiver

It is required that all youth players (2nd – 12th grade) AND parent/guardians of youth players (2nd – 12th grade) review and acknowledge (signature) the following Return to Play Waiver. Please review the “Peninsula Lacrosse Association Guidelines for safe return to Play during Covid-19 Pandemic 2020-21” as well as this waiver and submit to the PLA representative at practice, prior to participating in any PLA sponsored practice/event.

IMPORTANT: Please remember that all players and parent/guardians are required to execute a new waiver prior to being placed on a roster as well as participate in a practice/event as part of the Peninsula Lacrosse Association post Covid-19 guidelines. All players are currently in a pending status. Players will not be placed on a roster or allowed to participate in any practice/event until the waiver has been received. Once this waiver has been received and all other requirements met the player will be eligible to be placed on a roster and allowed to participate in the PLA sponsored practice/event.

Waiver

In consideration of being allowed to participate in any way in the PENINSULA LACROSSE ASSOCIATION athletics/sports program, related events and activities, the undersigned acknowledges, appreciates, and agrees that:

1. I have received, read, understand, and will comply with all mandates outlined in the “Peninsula Lacrosse Association Guidelines for safe return to Play during Covid-19 Pandemic 2020-21”.
2. The risk to have contact with individuals, who have been exposed to and/or have been diagnosed with one or more communicable diseases, including but not limited to COVID-19 or other medical conditions, diseases, or maladies does exist, and it is impossible to eliminate the risk that players/spectators could be exposed to and/or become infected through contact with or close proximity with an individual with a communicable disease.
3. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others and assume full responsibility for myself (player) / my player’s participation.
4. I willingly agree to comply with stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest PLA Coach or Representative immediately; and
5. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS THE PENINSULA LACROSSE ASSOCIATION, their officers, coaches, representatives, and other participants (“Releasees”) WITH RESPECT TO ANY AND ALL INJURY, ILLNESS, DISABILITY, DEATH, or loss or damage to person or property, WHETHER FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.
6. I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, BEFORE SIGNING BELOW, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY AGREEING TO IT ON MY OWN BEHALF OR ON THE BEHALF OF THE YOUTH PARTICIPANT ASSOCIATED WITH THIS GUARDIAN ACCONT, AND I SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
