Blanchester, Ohio will remain in District #26 as long as the Blanchester School District remains in the Southern Buckeye Conference (SBC) for their sports program. If and when the Blanchester School District leaves the SBC, then Blanchester will transfer to District #34 with the rest of Clinton County.
