  - **Fundraising-**

- **Scholastics-**
  - Overview of the recent NHYFSC banquet that took place 2/18/18. Congratulations to all Salem Rams recipients of Academic Achievement Awards and Scholarships!
  - Starting this year at equipment pickup parents will be asked to initial and sign off on a Scholastics checklist acknowledging what paperwork has and has not perhaps, been submitted so there are no future discrepancies on eligibility for Academic Achievement Awards.
  - A Committee was created within the board regarding distribution for High School Scholarships from the Salem Rams for 2018 graduates of Salem High School. Chris Homsey along with Debbie Ahlers, Kim Clements, Jamie Masson and Samantha Smith have volunteered to go over compiled applications and choose four deserving athletes to be awarded one of four \$1,000 scholarships based on the NHYFSC credentials. Proof of College enrollment will be required in order to be received.

- **Coaching-** Email to go out in the next week in search of Football & Cheer coaches. Interested individuals must fill out an application. - **Cheer-** Cheer clinic will most likely start in May and last 6 weeks.
