I, _____, hereby accept a position on a youth hockey team with

South Windsor Youth Hockey Association (“SWYHA”) for the 2019-20 Connecticut Hockey
Conference youth hockey season.

We, the undersigned player and parents/legal guardians of said player, by executing this Letter of
Commitment, agree to the following terms and conditions of this Commitment:

1. We agree to remain with South Windsor Youth Hockey Association for the entirety of the 2019-20 season.
2. We agree to pay the full season financial obligation for the program and/or team, said amount being the dues that are or will be established by the SWYHA Board of Directors for the team that the above-named player is assigned to.
3. We understand and agree that there are NO REFUNDS and that the fees for the entire season are due and payable in accordance with SWYHA’s payment schedule upon signing this Letter of Commitment.
4. Except as set forth below, we understand and agree that if the above-named player refuses to participate with the above-named program and team after signing this agreement that s/he is ineligible to participate with any other Connecticut Hockey Conference member program and must sit out the remainder of the 2019-20 season.
5. We understand and agree that a player who sits out due to refusal to participate remains obligated to satisfy any outstanding financial obligations due to the program for the 2019-20 season.
6. We understand and agree that a player who sits out all or a portion of the season is not entitled to any partial or full refund or forgiveness of program fees, expenses or dues.
7. We understand and agree the above-named player must obtain a proper Connecticut Hockey Conference Release from the above program, and satisfy any financial obligations to the program, prior to registering with any new program in any ensuing season.

We, the undersigned player and parents/legal guardians further understand and agree that:

1. After teams are announced following Tryouts, the coach(es) for the team may change.
2. After teams are announced following Tryouts, the number of players assigned to the team may change, either increasing or decreasing.
3. This Letter of Commitment is **NOT** nullified due to changes in players, player numbers or coaching staff for the team.
4. This Letter of Commitment is **NOT** contingent upon the team having particular coaches, players or player numbers. This Letter of Commitment is to play for SWYHA for the 2019-20 season and it remains in full force and effect even if there are changes to the team coach(es), players or numbers.

We, the undersigned player and parents/legal guardians further understand and agree that this Letter of Commitment may only be terminated by mutual consent between the Board of Directors of South Windsor Youth Hockey Association and player. Upon such mutual consent, and payment of any outstanding financial obligations, the program will issue a proper Connecticut Hockey Conference Release and the player may transfer to another program. Such mutually agreed on transfers must occur prior to November 1, 2019.
