<u>CHC</u> Playdown Rule	<p>CHC has a new playdown rule- if you are playing CHC games you have strict rostering rules. In CGHL we register to age of the oldest player. We allow approved players to playdown but the only playdowns allowed in CHC are for medical exceptions and need to be approved by CHC.</p> <p>If you are playing <u>only</u> CGHL games have your registers name your team with your team name followed by CGHL ie: Ridgefield U14 CGHL</p>
