- Preferred & attended parking available along the border of field A on Avenue H, 11th Street & E Avenue. (\$10 Cash ONLY – exact change appreciated.)
- **NO DOGS!** Please leave you furry friends at home.
- Only service dogs, with their vests, are allowed on the fields.
- Please be sure to pick up after yourselves (especially water bottles).

12B and 14B Flighted Tournament Game Format:

- Please have a badged coach check in at the NCJLA table at least 30 minutes prior to your first game. All coaches must wear their NCJLA badges.
- Scoresheets will be provided. (Pick up at NCJLA Tent)
- Rosters are due at table 10 minutes before game time.
- **Games will be 2 20-minute running clock halves with 1 timeout per team per game and 1 5-minute halftime. Clock will stop on every whistle last 1-minute of each half, unless there is a 4-goal differential.**
- Time will be kept at the table. Score must be kept. Fill in scoresheets as usual.
- NCJLA Rules Sheet and this info sheet and schedule will be taped to the tables.
- Each team must provide 1 adult scorekeeper/timer and 1 sideline manager.
- Higher seeded team is the “home” team and supplies 3 NOCSAE balls.
- **Winning Team** brings signed scoresheet to NCJLA Table/Tent immediately after game.
- Flight Champions will receive medals per player in attendance and have team photo taken immediately after last game. Runners up will also have photo taken for NCJLA website.

Overtime:

- NFHS Overtime procedures: (NCJLA modifications) 2 min rest period; alternate possession, and cards carry over into overtime. No coin toss for choice of ends, teams remain in place. Then a 3-minute sudden victory full team **stop clock** playing period, with substitutions allowed. No timeouts during 3 min play period.
- If no score after overtime: 2 min rest period, alternate possession and cards carry over, then a braveheart, three girls from each team plus a goalie play until a team wins, starts with a draw. No timeouts during a braveheart. No substitutions during a braveheart unless official calls time out for injury.

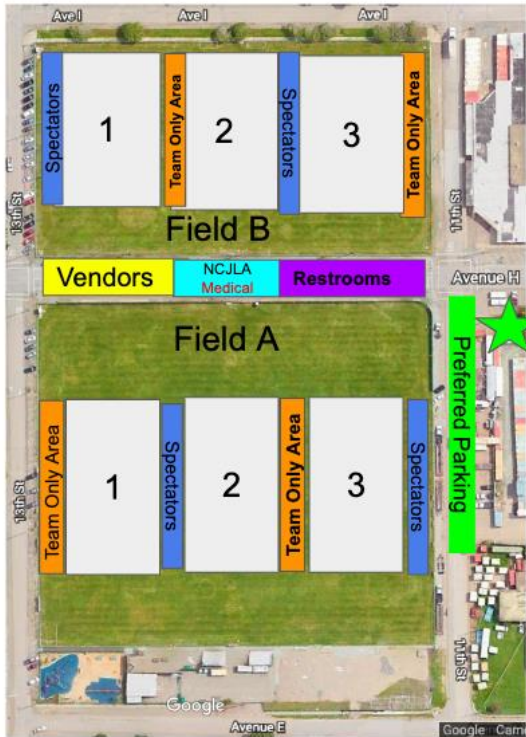

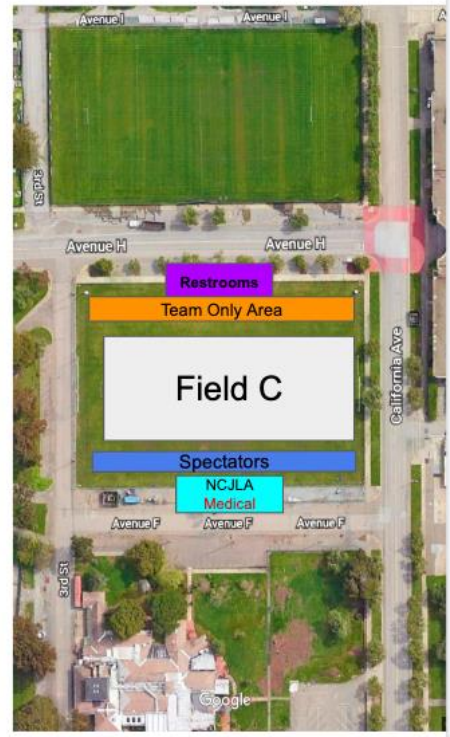
