

### Consent and Liability Waiver – Release of All Claims

As the adult person completing this registration process, I hereby certify that I am the parent or legal guardian of the minor child/children being registered. As consideration for my minor child being permitted to participate in any program, league, team, game, practice, camp, training session, activity, or other event offered by, through or on behalf of HULL YOUTH LACROSSE, I, for myself, my minor child, and for each of our respective heirs, executors, administrators, successors and assigns, hereby fully, unconditionally and irrevocably waive, release, and forever discharge any and all rights, actions, suits, claims, losses, liabilities, demands, causes of action, damages, liabilities, demands, complaints, and any and all other claims of every kind, nature and description whatsoever, whether known or unknown, in law or in equity, that we may now have or which we may ever have in the future against HULL YOUTH LACROSSE, its officers, directors, agents, employees, contractors, coaches, assistant coaches, and affiliates, and their respective heirs, legal representatives, successors and assigns, in both their official and individual capacities (hereinafter, collectively referred to as "HYL"), arising out of or relating in any way to my minor child's participation in any HYL program, league, team, game, practice, camp, training session, activity, or other event, including but not limited to any and all claims for personal injury, wrongful death or property damage that my minor child may sustain as a result of my child's participation in such HYL program, league, team, game, practice, camp, training session, activity, or other event. This Consent and Liability Waiver is intended to act as a general release of all claims against HYL, including but not limited to any and all claims for negligence, except for any liability that may arise out of the willful or wanton misconduct of HYL.

In consideration of being allowed to participate on behalf of the HYL program and related events and activities, the undersigned specifically acknowledges, appreciates, and agrees that:

1. Participation includes possible exposure to and illness from infectious diseases including but not limited to MRSA, influenza, and COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist; and
2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and
3. I willingly agree to comply with the stated and customary terms and conditions for participation as regards protection against infectious diseases. If, however, I observe and any unusual or significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and

4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS HYL and their officers, officials, agents, coaches, coordinators and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event (including Town of Hull and Hull Public Schools), ("RELEASEES"), WITH RESPECT TO ANY AND ALL ILLNESS, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

I FURTHER UNDERSTAND THAT YOUTH LACROSSE INVOLVES PHYSICAL CONTACT BETWEEN PLAYERS, THAT SERIOUS ACCIDENTS MAY OCCASIONALLY OCCUR DURING SUCH ACTIVITIES, AND THAT PARTICIPANTS IN SUCH ACTIVITIES MAY OCCASIONALLY SUSTAIN SERIOUS PERSONAL INJURIES (INCLUDING DEATH) AND/OR PROPERTY DAMAGE, AS A CONSEQUENCE THEREOF. KNOWING THE RISKS OF PARTICIPATION, I HEREBY ACKNOWLEDGE AND AGREE THAT MY MINOR CHILD AND I VOLUNTARILY ASSUME THOSE RISKS AND RELEASE AND HOLD HARMLESS HYL FROM AND AGAINST ANY AND ALL LIABILITY FOR LOSS OR INJURY THAT MAY OCCUR AS A RESULT OF NEGLIGENCE OR CARELESSNESS ON THE PART OF HYL.

I attest that I am eighteen (18) years of age or older and that my child is physically fit and has no known medical conditions which prohibit participation in this sport. My child and I agree to follow all rules, regulations and guidelines governing the conduct of any HYL program, league, team, game, practice, camp, training session, activity, or other event, including Massachusetts Youth Lacrosse Association Return to Lacrosse guidelines as well as the Commonwealth of Massachusetts COVID guidelines.

I HAVE CAREFULLY READ THIS CONSENT AND LIABILITY WAIVER AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS IS A GENERAL RELEASE OF LIABILITY FOR MYSELF AND MY CHILD, AND DO SO VOLUNTARILY AND OF MY OWN FREE WILL.

I acknowledge that my child's participation in HYL Lacrosse may be videotaped at any time. I hereby authorize HYL to use and publish photographs and/or videos of my minor child in connection with any future print, online, video, or other HYL promotional materials. I further release HYL from any reasonable expectation of privacy or confidentiality for myself and my minor child in connection with such photographs, videos and images, and I acknowledge and agree that neither I nor my minor child shall be entitled to receive any financial compensation in connection with the taking, use and publication of such photographs and images by HYL.

This Consent and Liability Waiver shall be governed by and construed in accordance with the laws of the Commonwealth of Massachusetts and is intended to be as broad and inclusive as permitted by applicable law. Should any provision or any part of this Consent and Liability Waiver be held to be invalid or legally unenforceable for any reason, the remainder hereof shall remain valid and fully enforceable.

In consideration of my child being allowed to participate in any way in the Lacrosse programs and activities and their related events and activities (the "Programs"), the undersigned, acknowledge, appreciate, and agree that:

The risk of injury and illness from the activities involved in the Programs is significant, including (without limitation) the potential for injury or illness – in particular and not by way of limitation, risks of exposure, directly or indirectly, arising out of, contributed to or by, or resulting from any infectious or communicable disease, including (without limitation) the current or any future outbreak of the novel coronavirus (COVID-19) and/or any mutation or variation thereof – and while particular skills, equipment and personal discipline may reduce this risk, the risk of serious injury or illness does exist. I knowingly and freely, for myself and on behalf of my child, assume all such risks, both known and unknown, even if arising from the negligence of the Releasees or others, and assume full responsibility for my and my child's participation in the Programs.

I consent to my child participating in the Programs.

I, for myself and on behalf of my child, and our respective heirs, assigns, personal representatives and next of kin, hereby release, indemnify, and hold harmless Hull Youth Lacrosse, its member organizations, and their respective directors, officers, employees, agents, associated personnel, volunteers, other participants, sponsoring agencies, sponsors, advertisers and, if applicable, owners and lessors of fields, facilities and premises utilized for the Programs (collectively, the "Releasees"), with respect to any and all injury, illness, disability, death or loss or damage to person or property associated with my or my child's presence at, or participation in the Programs, including being transported to or from the Programs, whether arising from the negligence of the Releasees or otherwise, to the fullest extent permitted by law.

I hereby authorize the transportation of my child to or from the Programs.

My child has received a physical examination by a licensed medical doctor and has been found physically capable of participating in the sport of Lacrosse. I have provided written notice attached to this release setting forth any specific issue, condition, or ailment that my child has that may impact my child's participation in the Programs. I give my consent to have an athletic trainer and/or licensed medical doctor or dentist provide my child with medical assistance and/or treatment and agree to be financially responsible for the reasonable cost of any such assistance and treatment.

When necessary, I understand that an uploaded or provided photo will only be used for printing on a credential (i.e., ID, Pass Card, Roster) and will not be used for any other purposes without express consent. I consent to Hull Youth Lacrosse and its affiliates taking photographs, video recordings, and/or sound recordings in documenting the activities of Hull Youth Lacrosse's programs and services. I hereby grant Hull Youth Lacrosse and its affiliates' permission to use the negatives, prints, motion pictures, video recordings, audio recordings, or any other reproduction of the same for Hull Youth Lacrosse and its affiliates' educational and promotional purposes in manuals, on flyers, the internet, or other publications.



My child and my child’s parents and guardians will abide by the rules, policies, procedures and protocols as provided by Hull Youth Lacrosse and members of Lacrosse, and all affiliated member organizations.

I understand and give permission for my child to participate in practices and games where they may be on the field with players of younger or older ages. I understand and accept there may be risks involved when playing with players of different ages. I am aware that if I do not accept such risks I may remove my child from the field.

I have read this release of liability and assumption of risk agreement, and fully understand its terms. I understand that I have given up substantial rights by electronically signing this document, and I sign it freely and voluntarily without any inducement. I hereby waive all such rights above including the right to file a legal action or assert a claim for personal or physical injury or death of any kind.
