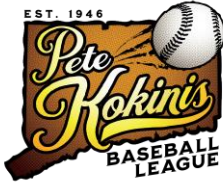

## Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

The Pete Kokinis Baseball League ("PKBL") has created new protocols and put in place preventative measures to reduce the spread of COVID-19; however, PKBL cannot guarantee that you or your child(ren) will not become infected with COVID-19.
