

BYL Free and Discounted Tuition Program

Billerica Youth Lacrosse recognizes volunteers who make significant commitments to the program with the opportunity for reimbursement of all or a portion of the Tuition for the Spring Season (special events, select teams are not included).

Head Coach

Head coaches in the boys and girls program currently coaching are eligible after the conclusion of second consecutive full season. A refund of 100% of the tuition for one child will be available by submitting a BLA Reimbursement Form to the BLA Board by June 30 of that year. With the conclusion of each subsequent year of coaching a 100% refund for one additional child will be available. The refund only applies to the children of the head coaches and is non-transferable.

Players must be paid in full at registration time. Submission of reimbursement form is to be completed no later than June 30th of the year you expect reimbursement for in order to be reviewed by the BLA Board during the July meeting.

Assistant Coach

Assistant coaches in the boys and girls program currently coaching are eligible at the conclusion of their second consecutive full season, and by participating in 75% of all team activities. A refund of \$ 25.00 of the tuition for one child will be available by submitting a BLA Reimbursement Form to the BLA Board by June 30 of that year. With the conclusion of each subsequent year of coaching a \$ 25.00 refund for one additional child will be available. The refund only applies to the children of the assistant coaches and is non-transferable.

Players must be paid in full at registration time. Submission of reimbursement form is to be completed no later than June 30th of the year you expect reimbursement for in order to be reviewed by the BLA Board during the July meeting.

BLA Board Members

BLA Board members, in good standing, are eligible for reimbursement at the conclusion of the Board Members second full and consecutive year. A refund of 100% of the tuition for one child will be available by submitting a BLA Reimbursement Form to the BLA Board by June 30 of that year. With the conclusion of each subsequent year a 100% refund for one additional child will be available. The refund only applies to the children of the board member and is non-transferable.

In order to be eligible, board members must have completed no less than 50 hours of service to the organization during the operating year (to be detailed on submission form):

Players must be paid in full at registration time. Submission of reimbursement form is to be completed no later than June 30th of the year you expect reimbursement for in order to be reviewed by the BLA Board during the July meeting.

Program Administration

Checks for all accepted requests will be sent as soon as administratively possible. Notifications of declined reimbursement requests will be sent from Treasurer to the submitter.
