

# Affidavit – MINOR EMPLOYEE Exemption from FBI Certification

I, \_\_\_\_\_ (minor) and \_\_\_\_\_ (Parent/Guardian), swear or affirm that MINOR applicant is between 14 & 17 years of age and is applying for a COMPENSATED position with \_\_\_\_\_ (organization) and as part of my duties I will be responsible for the welfare of children and will have direct contact with or am responsible for the care of children.

I understand that the Child Protective Services Law requires all Minor Employees to complete three (3) background clearances: (1) Department of Human Services Child Abuse Clearance; (2) Pennsylvania State Police criminal background clearance; and (3) FBI criminal background clearance. I further understand that the law may exempt a prospective Minor Employees from the federal clearance if I: (1) **have been a Pennsylvania resident during the entirety of the previous 10-year period or, if not a resident of Pennsylvania during the entirety of the previous 10-year period, have received certification under section 6344(a.2) (Minor Employees certification) at any time since establishing residency in Pennsylvania and I provide a copy of the certification to the person responsible for hiring minor employees** and (2) **swear or affirm in writing that I am not disqualified from service by reason of criminal history** and I hereby Swear or Affirm that:

(a) I have not been named in the statewide database maintained by the Dept. of Human Services as the perpetrator of a founded or indicated child abuse report committed within the five-year period immediately preceding verification. I have requested a child abuse background clearance from the Dept. of Human Services and a criminal background clearance from the Pennsylvania State Police. I am attaching copies of my clearances here. I understand that I will be required to produce original clearance reports before beginning service; and

(b) I have been a resident of Pennsylvania during the entire previous ten-year period and have not been arrested for or convicted of any of the offenses below or crimes similar in nature, or the attempt, solicitation, or conspiracy thereof, or a similar offense under the laws or former laws of the United States or one of its territories or possessions, another state, the District of Columbia, the Commonwealth of Puerto Rico, or a foreign nation, or under a former law of this Commonwealth:

- Section 2902 (unlawful restraint)
- Section 2910 (luring a child into a motor vehicle or structure)

- Section 3124.2 (institutional sexual assault)
- Section 3125 (aggravated indecent assault)
- Section 3126 (indecent assault)
- Section 3127 (indecent exposure)
- Section 3129 (sexual intercourse with animal)
- Section 4302 (incest)
- Section 4303 (concealing death of child)
- Section 4304 (endangering welfare of children)
- Section 3123 (involuntary deviate sexual intercourse)
- Section 4305 (dealing in infant children)
- Section 5902(b) (prostitution and related offenses)
- Section 5903(c) or (d) (obscene and other sexual materials and performances)
- Section 6301 (corruption of minors)
- Section 6312 (sexual abuse of children)
- Section 6318 (unlawful contact with minor)
- Section 6319 (solicitation of minors to traffic drugs)
- Section 6320 (sexual exploitation of children)

(c) I further swear that I have not been arrested for or convicted of a felony drug offense under the Controlled Substance, Drug, Device and Cosmetic Act.

(d) I understand that I may be accepted to serve on a provisional basis for a single period not to exceed thirty (30) days at the discretion of the organization. I swear or affirm that I am in compliance with the clearance standards under the law of the jurisdiction where I am domiciled. I further understand that, during any provisional period, I may not work alone with children and that I must work in the immediate vicinity of a permanent employee of the school.

**I hereby swear or affirm that the information set forth above is true and correct to the best of my knowledge and belief. I understand that if information is obtained that I am disqualified from service, I will be dismissed immediately. I also understand that I am signing this document subject to penalty under Sections 4903 of the Pennsylvania Criminal Code (false swearing).**
