Dear Professor Marquina

Post-Accreditation Guidelines:

Follow-up process after accreditation for 3 years:

Schools that are EQUIS accredited for a period of 3 years are requested to file a 5-10 pages annual update report on progress made in the Areas of Required Improvement indicated by the Accreditation Board. The reports are due immediately before the end of Year 1 and Year 2 (at the date of the accreditation by the EQUIS Accreditation Board). In addition, the School must go through a full re-accreditation process before the end of Year 3 and will be expected to produce convincing evidence that it has made real progress in the areas specified by the EQUIS Accreditation Board.

EQUIS Policy on Major Institutional Change and Restructuring (enclosure):
