Energy efficient choices can save families about a third on their energy bill with similar savings of greenhouse gas emissions, without sacrificing features, style or comfort. ENERGY STAR qualified appliances incorporate advanced technologies that use 10–50% less energy and water than standard models while delivering the same or better performance as comparable models. When looking for new household products, look for ones that have earned the ENERGY STAR.

ENERGY STAR® Lighting Program

Residential customers who purchase ENERGY STAR light bulbs and fixtures can receive instant rebate coupons redeemable at participating retailers. The instant rebates are already deducted from the prices you'll find in this catalog for all of our ENERGY STAR lighting and energy saving products. A typical ENERGY STAR rated Compact Fluorescent Lamp (CFL) lasts up to 10 times longer than an equivalent incandescent bulb and uses 75 percent less energy.

Rebate* levels for energy efficient lights and fixtures are:

- \$1 on compact fluorescent light bulbs (CFLs) at participating retailers
- \$2 on CFL light bulbs in this catalog
- \$10 on interior and exterior light fixtures and torchieres in this catalog and at participating retailers

ENERGY STAR® Appliance Program

Residential customers will receive mail-in or instant rebates towards the purchase of the following ENERGY STAR rated appliances* at participating retailers:

- \$30 on clothes washers
- \$30 on refrigerators (available after January 1, 2011)
- \$20 on room air conditioners
- \$15 on room air cleaners (available after January 1, 2011)
- \$10 on smart strips

ENERGY STAR Homes Program

The New Hampshire ENERGY STAR Homes Program encourages customers to take advantage of the benefits of building a new (or completely renovating an existing) single or multi-family energy efficient home. ENERGY STAR construction results in reduced monthly operating costs, improved homeowner comfort, and a higher resale value, while providing greater environmental benefits. The program provides assistance in evaluating your new home plans, air leakage testing, and incentives including those for ENERGY STAR appliances and lighting systems.

All participating homes are eligible to receive a nationally recognized Home Energy Rating (HERS) to identify the energy efficiency of your home. The lower the rating, the more energy efficient your home.

Home Energy Assistance Program

This program helps income-qualified customers with high electric use understand their energy use with the goal of lowering energy costs. Qualified customers living in an apartment or house, either rented or owned, can receive up to \$5,000 in services, including a customized report helping them better understand their home, factors affecting their energy use, and recommendations on how to use energy more efficiently. Additional funds may be available to customers who qualify for the New Hampshire Weatherization Assistance Program.

Services include, but are not limited to:

- Insulation
- Air sealing
- Thermostats
- Electric hot water measures
- Refrigerator/freezer replacement
- Energy efficient lighting upgrades
- Education
- Health & safety measures
- Home energy assessment
- Lighting, windows and doors for mobile homes
- Heating system replacement

Home Performance with ENERGY STAR

This program assists customers in maximizing the energy efficiency of their homes. Customers can receive up to \$4,000 in rebates and services for qualified energy efficiency improvements.

Services include:

- Weatherization measures: insulation, air sealing, thermostats, electric hot water measures
- Refrigerator rebates
- Energy efficient lighting upgrades
- Home energy assessment
