PRIVACY POLICY

At Tate & Foss Sotheby's International Realty, your privacy is important to us, and maintaining your trust and confidence is a high priority. The purpose of this notice is to explain our Privacy Policy with regard to personal information about you that we obtain and how we keep that information secure. This policy also explains how you can update or delete your personal information at any time.

This Privacy Policy explains the different types of information we collect about you when you visit our website, and how that information is used. If you do not agree with the terms of this Privacy Policy, please do not use our website.

DISCLOSURE OF PERSONAL INFORMATION

We gather two types of customer information: the data that you voluntarily provide to us when registering on our site, and data we gather through aggregated tracking of page views throughout our site. Aggregate information is non-personally identifiable information about you, and may include your IP address, the time and frequency of your visits and the features on our website which you viewed.

You have the option, when visiting our website, of creating an account so that you can receive alerts, contact agents, follow homes, or gather information about our services or the communities we serve. Such information is provided to us with your authorization or consent. Additionally, we do not disclose any non-public personal information about current or former clients obtained in the course of representation, except as expressly or impliedly authorized by those clients to enable us to effectuate the purpose of our representation

or as required or permitted by law or applicable provisions of the licensing regulations or ethical rules governing our conduct.

We may also gather additional search information about your visit to our website based on your search history. Such information enables us to tailor our content to fit your needs better and to help advertisers understand our audience. We do not disclose personal information to third parties without your consent. This information can track the frequency of visits, pages viewed and other trends. It allows us to contact you to suggest tools and services to assist you in your search, or to inform you of new real estate listings or relevant products, information or news. You have the option of opting out of receiving promotional emails from us at any time.

CONFIDENTIALITY AND SECURITY

Tate & Foss Sotheby's International Realty collects records relating to professional services that we provide so that we are better able to assist you with your professional needs and to comply with professional guidelines or requirements of law.
