XXXchurch developed X3watch, which is a free internet accountability software used by over 1 million people. X3watch now has a premium based software. The proceeds are used to fund other ministry projects and the free version of X3watch.

Strip Church serves, teaches, and equips women who share a heart and calling to reach out into clubs. We do training conferences each year where people have the opportunity to be trained to do strip club ministry in their cities across the U.S. This network will be supported through monthly training conference calls, resources, networked websites, blogs, prayer, and branded materials to use inside the clubs. We have over 80 cities currently in the network.
