Note: A completed and signed copy of this form is required to be uploaded as a Supplement to the listing in the MCRTC MLS. **All signatures below of all owners and listing broker/ office manager or authorized agent are required for validation – NO changes or strikethroughs will be accepted.**

- The Coming Soon Status will automatically become a fully Active listing on its On Market Date. **The On Market Date:** Aug 21, 2026 cannot be greater than 21 days from the List Date.
- Properties in **Coming Soon** Status cannot be shown by *ANYONE*. Any showing of a property in **Coming Soon** Status disqualifies the property from this status and must immediately be changed to Active status.
- If the listing broker receives any offers on the property during the **Coming Soon** Status, the listing broker is required to report offers to the Seller. The seller(s) and listing agent agree no offers will be accepted while listing is in **Coming Soon** status and the listing status must be changed to Active before acceptance of any offer.
- As soon as the listed property is available for showings, the status of the listing must be changed to Active.
- If the property is not ready for showings upon reaching the *On Market Date*, the listing agent can change the listing status to *Temporarily Off Market* or *Cancelled* status in the MCRTC MLS.
- A property can only be listed in the Coming Soon Status once per year unless the property has been sold or rented or the property is listed with a new brokerage firm.
