- Amend C.S.H.B. No. 5339 (house committee report) as follows:
- 2 (1) On page 1, lines 14 through 15, strike "<u>, as an</u>
- 3 organization described by Section 501(c)(3) of that code".
- 4 (2) On page 2, strike lines 24 through 26 and renumber
- 5 subsequent subdivisions of added Section 61.9852(a), Education
- 6 Code, and cross-references to those subdivisions, accordingly.
- 7 (3) On page 3, line 19, strike "pesticide usage" and
- 8 substitute "the use of synthetic inputs".
- 9 (4) On page 4, line 26, strike "pesticide use" and
- 10 substitute "the use of synthetic inputs".
- 11 (5) Strike page 5, line 9, through page 6, line 6, and
- 12 substitute the following:
- Sec. 61.9853. GRANT ELIGIBILITY. To be eligible to receive
- 14 a grant under the program for a state fiscal year, an institution of
- 15 higher education must:
- (1) apply to the board in the manner prescribed by
- 17 board rule; and
- (2) satisfy any other criteria prescribed by board
- 19 rule in accordance with this subchapter.
- 20 (6) On page 6, line 9, strike "an" and substitute "any one".
- 21 (7) On page 6, between lines 10 and 11, insert the
- 22 following:
- 23 (b) In awarding grants under the program, the board shall
- 24 give first and equal priority to institutions of higher education
- 25 <u>that:</u>
- 26 (1) conduct research in partnership with one or more
- 27 nonprofit organizations; or
- 28 (2) both:
- 29 (A) conduct research in partnership with a

- 1 nonprofit organization described by Section 501(c)(3), Internal
- 2 Revenue Code of 1986; and
- 3 (B) do not derive more than 25 percent of the
- 4 institution's agricultural grant program funding from an entity
- 5 that manufactures, markets, or sells synthetic inputs for use in
- 6 farming.
- 7 (8) On page 6, line 11, strike "(b)" and substitute "(c)".
- 8 (9) On page 6, line 14, between "statewide" and the
- 9 underlined period, insert "that do not qualify for a priority grant
- 10 award under Subsection (b)".
- 11 (10) On page 7, line 12, immediately following the
- 12 underlined semicolon, insert "and".
- 13 (11) On page 7, strike lines 13 through 18 and renumber
- 14 subsequent subdivisions of added Section 61.9855, Education Code,
- 15 and cross-references to those subdivisions, accordingly.
- 16 (12) On page 7, line 22, strike "commission" and substitute
- 17 "board".
- 18 (13) On page 8, line 6, immediately following the underlined
- 19 semicolon, insert "and".
- 20 (14) On page 8, strike lines 7 through 8 and renumber
- 21 subsequent subdivisions of added Section 61.9858, Education Code,
- 22 and cross-references to those subdivisions, accordingly.
