1 moves to amend the bill on page 1, lines 12-13, by rewriting the lines to read:

3 "A parent, guardian, custodian, or caretaker who raises a juvenile consistent with the juvenile's
4 biological sex, who raises a juvenile supportively in terms of gender transition, or who refers to
5 a juvenile consistent with the juvenile's biological sex or the biological sex with which the
6 juvenile identifies, shall not";

8 and on page 1, lines 27-28, by inserting between the lines the following:

10 "(3) The adoptive parents' willingness or support to enable the child to engage in
11 gender transition.";

13 and on page 2, lines 1-4, by rewriting the lines to read:

15 "(d) Any parent of a child less than 18 years of age, or any other person providing care to
16 or supervision of the child, is not guilty of a violation of this section for raising a child consistent
17 with the child's biological sex or for raising a child supportively in terms of gender transition,
18 including referring to a child consistent with the child's biological sex or gender identity, and
19 making related mental health or medical decisions based on the child's biological sex or gender
20 identity.";

22 and on page 2, lines 11-14, by rewriting the lines to read:

24 "(c1) Any parent of a child less than 18 years of age, or any other person providing care to
25 or supervision of the child, is not guilty of a violation of this section for raising a child consistent
26 with the child's biological sex or for raising a child supportively in terms of gender transition,
27 including referring to a child consistent with the child's biological sex or gender identity, and
28 making related mental health or medical decisions based on the child's biological sex or gender
29 identity.";
