An act to amend Section 8266 of the Welfare and Institutions Code, relating to homelessness.

LEGISLATIVE COUNSEL'S DIGEST

SB 814, as introduced, Rubio. Homelessness.

Existing law requires the Governor to create a California Interagency Council on Homelessness for specified purposes, including to create partnerships among various entities, like participants in the United States Department of Housing and Urban Development's Continuum of Care Program, and to identify mainstream resources, benefits, and services that can be accessed to prevent and end homelessness in California.

Existing law requires the council to set and measure progress toward goals to prevent and end homelessness among domestic violence survivors and their children and among unaccompanied women in California, as specified. The bill would require initial goals to be established by January 1, 2025, and those goals to be evaluated at least every 2 years to determine whether updated goals are needed.

This bill would instead require the council to evaluate the above-described goals at least every year.

The people of the State of California do enact as follows:

(3) (A) When funding is available, providing technical
assistance to cities, counties, and continuums of care to support
the development of local programs and plans that address the needs
of domestic violence survivors and their children and of

27 (B) In addition to subparagraph (A), working with the United

28 States Department of Housing and Urban Development to provide 29 technical assistance to cities, counties, and continuums of care in

30 furtherance of this section.

(b) The California Interagency Council on Homelessness shall
establish initial goals, as described in subdivision (a), by January
1, 2025, and evaluate these goals at least every two years year to
