

HOUSE BILL No. 1109

DIGEST OF INTRODUCED BILL

Citations Affected: IC 25-23-1-19.2; IC 25-23.4-4-3.5; IC 25-27.5-6-9.

Synopsis: Collaborative care disclosures. Provides that if an advanced practice registered nurse, a certified direct entry midwife, or a physician assistant is under a collaborative agreement with a licensed practitioner or physician, the advanced practice registered nurse, certified direct entry midwife, or physician assistant must display or provide certain information in an office based setting, to the patient, and, if applicable, on a website.

Effective: July 1, 2023.

HOUSE BILL No. 1109

A BILL FOR AN ACT to amend the Indiana Code concerning professions and occupations.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 25-23-1-19.2 IS ADDED TO THE INDIANA
2 CODE AS A **NEW** SECTION TO READ AS FOLLOWS
3 [EFFECTIVE JULY 1, 2023]: **Sec. 19.2. (a) An advanced practice**
4 **registered nurse who is under a collaborative agreement with a**
5 **licensed practitioner (as defined by section 19.4(b) of this chapter)**
6 **shall, in an office based setting, conspicuously display the advanced**
7 **practice registered nurse's:**
8 (1) name;
9 (2) type of license;
10 (3) primary board certification, if any;
11 (4) specialty, if any; and
12 (5) collaborative practitioner's primary practice address.
13 (b) An advanced practice registered nurse shall provide the
14 information that is required in subsection (a)(1) through (a)(5), in
15 writing, to a patient during the initial visit with the patient.
16 (c) If an advanced practice registered nurse advertises the
17 advanced practice registered nurse's services on a website, the



1 advanced practice registered nurse shall provide the information
 2 that is required in subsection (a)(1) through (a)(5) on the website
 3 advertisement.

4 SECTION 2. IC 25-23.4-4-3.5 IS ADDED TO THE INDIANA
 5 CODE AS A NEW SECTION TO READ AS FOLLOWS
 6 [EFFECTIVE JULY 1, 2023]: Sec. 3.5. (a) A certified direct entry
 7 midwife who is under a collaborative agreement with a physician
 8 shall, in an office based setting, conspicuously display the certified
 9 direct entry midwife's:

- 10 (1) name;
- 11 (2) type of license;
- 12 (3) primary board certification, if any;
- 13 (4) specialty, if any; and
- 14 (5) collaborative physician's primary practice address.

15 (b) A certified direct entry midwife shall provide the
 16 information that is required in subsection (a)(1) through (a)(5), in
 17 writing, to a patient during the initial visit with the patient.

18 (c) If a certified direct entry midwife advertises the certified
 19 direct entry midwife's services on a website, the certified direct
 20 entry midwife shall provide the information that is required in
 21 subsection (a)(1) through (a)(5) on the website advertisement.

22 SECTION 3. IC 25-27.5-6-9 IS ADDED TO THE INDIANA CODE
 23 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
 24 1, 2023]: Sec. 9. (a) A physician assistant who is under a
 25 collaborative agreement with a physician shall, in an office based
 26 setting, conspicuously display the physician assistant's:

- 27 (1) name;
- 28 (2) type of license;
- 29 (3) primary board certification, if any;
- 30 (4) specialty, if any; and
- 31 (5) collaborative physician's primary practice address.

32 (b) A physician assistant shall provide the information that is
 33 required in subsection (a)(1) through (a)(5), in writing, to a patient
 34 during the initial visit with the patient.

35 (c) If a physician assistant advertises the physician assistant's
 36 services on a website, the physician assistant shall provide the
 37 information that is required in subsection (a)(1) through (a)(5) on
 38 the website advertisement.
